### Payment terms for Part-A of the Contract

Payment will be made only after satisfactory completion of the Job stipulated in the tender in totality (on submission of final report) against each work order. Such payment shall be made on the work actually done allowing for deviations and any deductions and the measurement shall be checked and certified correct by the Company's authorized representative before any such payment is made. Payment shall be made within thirty (30) days after receipt of such invoice.

# Payment terms for Part-B of the Contract

The Company shall pay the Contractor only for actual work done at the all-inclusive rates set down in BOQ of this Contract. Payment for O&M (Operation & Maintenance) charges shall be made on Monthly basis after completion of Month within thirty (30) days after receipt of such invoice.
