1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY.

4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

Pipe cold cutting and Bevelling Machine.

Cutter Drive: Pneumatic air motor
coupled with worm gearbox.

Cutter Speed: Pneumatic: Adjustable from 30 to 50 rpm
for use on work-hardened alloys.

Feed: Pneumatic: Air motor coupled through
overload clutch, gearbox and chain reduction to final
machine drive sprocket.

The machine has to be a portable milling machine for pipes of diameter range from 10-24 inches.

- The machine has to provide cold cutting, bevelling and grooving operation for use on oil & gas pipelines.
- The machine must be capable of using multiple drives.
- The machine must be able to generate any bevel angle on any wall thickness on any material.
- Capability of using gang cutters.
- Machine must be secured and tensioned on its own.
- Machine should drive itself around the pipe.
- Machine must be capable of horizontal and vertical operation.
- Machine must use guide tracks for exceptional performance.
- Machine must have capability of continuous out of round compensation.
- Machine must have positive drive.
- Machine must be able to work in Mud, ditch, pipe shop or field.
- Machine must work in a pool of hot oil and gas environments.
- Machine must have anti corrosive components.
- Machine must be able to generate Victaulic grooves.
- Machine must have 0-60 variable RPM capability.
- Machine should have overload clutch, reduction and gearbox for exceptional performance.
- Machine must have variable linear speed of 3 inches per minute.
- Machine should have interlock controls for safety.
- Machine must have chain feed system.
- Machine should have provision for various controls and forward reverse travel direction.
- Machine should use pins and chains for extension.
- Machine should have longer spindle option.
- Machine should be locally supported for after sales and service with parts, tooling and accessories.
