- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

INTEGRITY PACT:

OIL shall be entering into an Integrity Pact with the Bidders as per format enclosed vide PART-5 of the Bid Document. The Integrity Pact has been duly signed digitally by OIL's competent signatory and uploaded in the OIL's e-portal. The Integrity Pact shall be returned by the bidder (along with the technical Bid) duly signed by the same signatory who signed the Bid i.e. who is duly authorized to sign the Bid. Uploading

the Integrity Pact in the OIL's E-portal with digital signature will be construed that all pages of the Integrity Pact has been signed by the bidder's authorized signatory who has signed the bid. If any bidder refuses to sign Integrity Pact or declines to submit the Integrity Pact, their bid shall be rejected straightway.

1.1.1 In case of a Joint venture, all the partners of the joint venture should sign the Integrity Pact.

- 1.3 In the event of any dispute between the management and the contractor relating to those contracts where Integrity Pact is applicable, in case, both the parties are agreeable, they may try to settle dispute through mediation before the panel of IEMs in a time bound manner. If required, the organizations may adopt any mediation rules for this purpose. In case, the dispute remains unresolved even after mediation by the panel of IEMs, the organization may take further action as per the terms and conditions of the contract. The fees/expenses on dispute resolution shall be equally shared by both the parties.

3.0 The Service Charge (in percentage) will remain firm and free from any escalation during the entire period of the Contract. It includes charges towards all the services under

the Terms of Reference / Scope of Work of the Contract including and not limited to maintenance of the Contractor's Personnel, equipment, out of pocket expenses, conveyance etc. and all applicable statutory taxes and duties.

- 4.0 Service Charge in percentage must not be less than 5% (Five per cent) and more than 7.5% (Seven Point Five Per cent) of the Total Price excluding GST for all 4 categories. The percentage value up to two decimal points will only be considered. The offer from bidder quoting below 5% and above 7.5% will be rejected.
- 5.0 The Personnel to be deployed by the service provider will be selected by the Company.
- 6.0 The service provider should be registered with Labour Dept. of Government of Andhra Pradesh, holding a valid license under the latest Contract Labour (Regulation & Abolition) Act and should be having valid ESI, EPF Code No., Income-tax Account No., GST No., etc.
- 7.0 The service provider has to submit an undertaking that he will pay wages to his employees not less than what he is getting from the principal employer.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
