1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The bidder shall be manufacturer or their authorised dealers/channel partners only. In case of authorised dealers or channel partners, they must submit valid dealership certificate along with the offer.
2. Catalogue/technical details of the offered item must be submitted along with the offer for technical evaluation.
3. The items shall be guaranteed for at least 12 months from the date of receipt.
4. Packing of materials should be adequate to avoid ingress of water/moisture and any transit damage. If any damage found at the time of receive, the item must replaced with new one by the party with their own cost.
5. IEC compliance certificate as mentioned in the specs shall be submitted along with the offer.

Disclaimer
