1. Generic

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. 2. Generic

In view of the same, an ATC may be incorporated in GeM, viz, "BIDDER/OEM must provide Proforma Invoice for processeing for EC application within 45 days from date of issue of GeM Contract and material should be dispatche after receiving of EC rom DGH."

3. **Scope of Supply**

4. **Buyer Added Bid Specific ATC**

A.0 The items must be delivered within 24 weeks from the date of placement of Purchase Order.

B.0 Bidders must submit all relevant technical catalogues and literature along with the offer without which the offer will be rejected.

C.0 The warranty period of the item should be for a minimum of 18 months from the date of dispatch / shipment or 12 months from the date of receipt.

D.0 Bidder must be OEM or OEM authorized dealer. Bidders other than OEM must provide the certificate of authorisation from OEM at the time of bid submission.

E.0 The offer must be submitted along with sample traceability certificate without which it will be liable for rejection.

F.0 The material supply should be accompanied with test, calibration and warranty certificates.

G.0 PBG must be valid for Twenty (20) months from the date of GeM Contract delivery period (completed) and claim period atleast for minimum one (01) year after expiry of PBG.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
