# ${\tt 3.}$ Inspection of Stores by Nominated Inspection Authority / Agency of buyer or their authorized representatives

An independent third party Professional Inspection Body can help buyer in mitigating buyer's risk with predispatch/post-dispatch inspection in order to ensure that equipment, components, solutions and documentation conform to contractual requirements. The buyer has a right to inspect goods in reasonable manner and within reasonable time at any reasonable place as indicated in contract. Inspection Fee/ Charges (as pre-greed between buyer and Inspection Agency) would be borne by the buyer as per their internal arrangement but may be recovered from the seller if the consignment failed to conform to contractual specification and got rejected by the Inspection Officer .If so requested and accepted by the seller , initially seller may pay for inspection charges as applicable and get the same reimbursed from buyer if consignment accepted by the Inspecting Officer . For reimbursement seller has to submit proof of payment to Inspection Agency.

Seller/OEM shall send a notice in writing / e-mail to the Inspecting officer / inspection agency specifying the place of inspection as per contract and the Inspecting officer shall on receipt of such notice notify to the seller the date and time when the stores would be inspected. The seller shall, at his own expenses, afford to the Inspecting officer, all reasonable facilities as may be necessary for satisfying himself that the stores are being and or have been manufactured in accordance with the technical particulars governing the supply. The decision of the purchaser representative /inspection authority regarding acceptance / rejection of consignment shall be final and binding on the seller.

The Seller shall provide, without any extra charge, all materials, tools, labour and assistance of every kind which the Inspecting officer may demand of him for any test, and examination, other than special or independent test, which he shall require to be made on the seller's premises and the seller shall bear and pay all costs attendant thereon.

The seller shall also provide and deliver store / sample from consignment under inspection free of charge at any such place other than his premises as the Inspecting officer may specify for acceptance tests for which seller/OEM does not have the facilities or for special/ independent tests.

In the event of rejection of stores or any part thereof by the Inspecting officer basis testing outside owing to lack of test facility at sellers premises, the seller shall, on demand, pay to the buyer the costs incurred in the inspection and/or test. Unless otherwise provided for in the contract, the quantity of the stores or materials expended in test will be borne by seller.

Inspecting officer is the Final Authority to Certify Performance / accept the consignment. The Inspecting officer's decision as regards the rejection shall be final and binding on the seller.

#### 1. SCOPE OF SUPPLY

- 1.1. Supply of Brand new Horizontal Spindle Reciprocating Table CNC (Computer Numerical Control)
  Surface Grinder along with all standard accessories
- 1.2. Installation, Commissioning and training of at least 8 nos. Oil personnel regarding operation & maintenance of the machine

#### 2. FEATURES OF THE MACHINE

- 2.1. 2 Axis CNC Controlled Horizontal Spindle Reciprocating Table CNC Surface Grinding machine
- 2.2. Machine shall be able to carry out Straight Track Grinding by Intermittent Transverse movement of spindle head, Plunge Grinding of Plane Surface, Angles Vees and Profiles, Face Grinding of vertical surface and T-slots and Cross Grinding by continuous cross traverse of grinding wheel spindle head
- 2.3. The spindle shall be mounted on rigid column attached to the bed. The vertical guide ways for vertical movement of spindle shall be coated with Turcite material. The Colum shall encase counter weight.

## 4. CNC CONTROL SYSTEM

- 4.1. Machine shall be equipped with CNC control system for spindle movement in vertical and Transverse direction
- 4.2. CNC control system shall be of Siemens / Fanuc make. A detail technical specification of the CNC Control system shall be submitted along with the offer
- 4.3. The CNC System/ Control panel shall have features like Jog, Offset, Electronic hand wheel for spindle movement control etc.
- 4.4. Control panel shall have Approx. 8 " Color Display
- 4.5. Control panel shall have feature to prepare CNC programming for Job, on Control panel itself and CNC Program can also be uploaded to CNC Control panel from outside through USB. Thus the control panel shall be equipped with sufficient switches to make CNC programming. Detail technical specification along with pictorial view of the control panel shall be submitted along with the Offer.
- 4.6. The control panel shall be installed on machine suitably located for a clear view. The control panel shall be manufactured of a corrosion resistant material and shall include permanent labelling of all controls and instrumentation. The control panel shall include an HMI- Human Machine Interface (colour TFT display) with touch screen or Keypad screen and alarm/ shutdown set point / operation details shall be configurable via HMI. The display/monitoring panel shall be an anti-reflective glass panel for increased visibility.
