by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Buyer Added Bid Specific Terms and Conditions

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

I. . BID REJECTION CRITERIA (BRC):

The bid shall conform generally to the specifications, terms and conditions given in this document. Notwithstanding the general conformity of the bids to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected.

A) TECHNICAL:

- Bidder should have the experience of successfully executing at least 1(one) similar Order / Project for value not less than Rs 8.21 Lakhs in preceding 5(five) years as on the original Bid Closing Date of this Tender.

"Similar order means supplying, Installation and Commissioning of LED Area lighting/street lighting/HPSV/SON street lighting/High mast with all accessories required for illumination"

Note: Documentary evidence in respect of the above should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as –

- (i) Satisfactory Inspection Report (OR)
- (ii) Satisfactory Supply Completion / Installation Report (OR)
- (iii) Consignee Receipted Delivery Challans (OR)
- (iv) Central Excise Gate Pass / Tax, Invoices issued under relevant rules of Central Excise / VAT (OR)
- (v) Any other documentary evidence that can substantiate the satisfactory execution of each of the purchase orders cited above.

Note:

a) The Purchase Order date need not be within 5 (five) years preceding original bid closing date of this tender. However, the execution of supply should be within 5 (five) years preceding original bid closing date of this tender.

b) Satisfactory supply/completion/installation report (if submitted) should be issued on client's official letterhead with signature and stamp.

B) FINANCIAL

a) Annual Financial Turnover of the bidder during any of preceding 03 (three) financial / accounting years from the original bid closing date should be at least **Rs8.21 Lakhs.**

b) Net Worth of the firm should be Positive for preceding financial / Accounting year. (FY=2021-2022)

Note -For (a) & (b): Considering the time required for preparation of Financial Statements, if the last date of preceding financial / accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial / accounting year are not available with the bidder, then the financial turnover of the previous three financial / accounting years excluding the preceding financial / accounting year will be considered. In such cases, the Net worth of the previous financial / accounting year excluding the preceding financial / accounting year will be considered. However, the bidder has to submit an affidavit/undertaking certifying that 'the balance sheet/Financial Statements for the financial year..... (As the case may be) has actually not been audited so far'.

Notes:

a) For proof of Annual Turnover & Net worth any one of the following documents must be submitted along with the bid: -

i) A certificate issued by a practicing Chartered Cost Accountant (with Membership Number and Firm Registration Number), certifying the Annual turnover & Net worth as per format prescribed in ANNEXURE-J.
OR

Audited Balance Sheet along with Profit & Loss account.

b) In case the bidder is a Central Govt. Organization/PSU/State Govt. Organization/Semi-State Govt. Organization or any other Central/State Govt. Undertaking, where the auditor is appointed only after the approval of Comptroller and Auditor General of India and the Central Government, their certificates may be accepted even though FRN is not available. However, bidder to provide documentary evidence for the same.

II. SPECIAL TERMS AND CONDITIONS

A. FOR 90 W LED LUMINARIES & 120 W LED LUMINARIES

(1) Bidder to submit a copy of LM- 80-08 test report for the LED along with the bid.

(2) Bidder to submit Type Test LM-79-08 report for the offered model from NABL accredited Lab. along with the bid. In case LM-79-08 report is from OEM's own lab, then copy of NABL accreditation certificate for the OEM's Lab is to be provided.

(3) Bidder to submit a certificate from OEM stating that the LED Driver is manufactured in India as per BIS no. 15885-Part2 for safety of the lamp and IS 16104:2012 for performance of the driver

(4) Bidder to submit a certificate from OEM stating that the luminaries is manufactured as per BIS no. 16107:2012 part -1 for performance of the luminaries

(5) Bidder/OEM to confirm that LED luminaries have OEM's name embossed in them.

(6) LED Luminaries and the driver shall be covered under warranty for replacement for a period of 4 years from the date of commissioning.

B. FOR 9 METER GI POLE

- 1) The party should confirm their manufacturing and testing facility at their work and agree for stage wise inspection for Pole during manufacturing stage, as wished by OIL. OIL also reserves the right to carry out the final inspection at the manufacturer's premises before despatch.
- 2) Poles should be guaranteed for at least 12 months from the date of installation or 18 months from the date of manufacturing.

C. GENERAL TERMS AND CONDITIONS:

1.Quotation along with all relevant documents and technical literature/catalogue/leaflet of offered models in regard to the following should be submitted along with the offer for technical evaluation.

- a. Luminaries
- b. Poles
- c. Junction box
- d. Cables

2. Before quoting, bidder should fully understand the scope of work under installation & commissioning. The bidder may visit the proposed site to understand the essence of the project.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents/clauses shall also be null and void. If any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations. Also, GeM does not permit collection of Tender fee / Auction fee in case of Bids / Forward Auction as the case may be. Any stipulation by the Buyer seeking payment of Tender Fee / Auction fee through ATC clauses would be treated as null and void.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
