If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Water Cooler Specifications:

Water Cooler, suitable for 230V \pm 10%,50 HZ, single phase.

A) In addition to the golden parameters, the bidder must also comply the following additional specifications:

- i. Model: Similar to RS-40/80 of VOLTAS, SS 4080 of USHA, SDLX-4080 of Blue Star Limited.
- ii. Storage capacity: 80 Litters.
- iii. Cooling capacity: 40 Litters/Hr.
- iv. Refrigerant: R134a /R600a.
- v. Condenser Tubing: Grooved Copper
- vi. Compressor: Hermetically Sealed Reciprocating.
- vii. Should have stainless steel body, tank & wastewater tray.
- viii. Should have PUF insulation.
- ix. Facility for easy adjustment of water temperatures from outside.
- x. The water cooler shall be conforming to IS: 1475 with latest amendment.

B) GUARANTEE:

Water Cooler shall be warrantee for one year against any manufacturing defect from the date of acceptance at site and the compressor should be guaranteed for 5 years from the date of supply.

C) DOCUMENTS:

1. At the time of Offer:

- i) Catalogue containing the features of offered make and model.
- ii) Valid authorized dealership certificate.

2. At the time of Supply:

- i) Duly signed Guarantee certificate.
- ii) One set of operation & maintenance manual against each unit.

D) AFTER SALES SERVICE:

a. The bidder shall confirm to provide after sales services of the units supplied.

b. The bidder shall furnish the name and address of their authorised service center(s) in the district of Tinsukia / Dibrugarh / Sivasagar / Jorhat in Assam ; Guwahati.

E) APPLICABILITY OF BANNING POLICY:

"Banning Policy dated 6th January, 2017 as uploaded in OIL's website and revised guidelines of banning/debarment vide OM no. F.1/20/2018-PPD dated 02.11.2021 issued by Department of Expenditure, Ministry of Finance, Govt of India will be applicable against the tender (and order in case of award) to deal with any agency (bidder/contractor/supplier/vendor/service provider) who commits deception, default, fraud or indulged in other misconduct of whatsoever nature in the tendering process and/or order execution processes.
