A scanned copy of the bid security shall however be uploaded in GeM portal along with the Technical Bid. The amount of Bid Security shall be as specified in the Bid Document.

Bidder should not upload any price in the technical bid. Any mention of such facts will result in out right rejection of the bid.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
