2. Generic

- **1.0** Bidders must provide Technical Catalogues / leaflets showing that the offered items/equipment meet/e xceed the specifications mentioned for items this Tender (Bid Document).
 - (a) The offered item(s) must be as per the BOQ specification document attached in bid.
 (b) Installation & Commissioning to be completed within 30 days after receipt of site clearance intimation by OIL.
 - (c) The bidder shall confirm that the materials shall be guaranteed for a period of 18 m onths from the date of despatch or 12 months from the date of receipt at destination, whichever is earlier, against defects arising from faulty materials, workmanship or desi gn.
