#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

shall commence bulk supply only upon confirmation by OIL towards acceptance of the sample, failing which the entire supply may not be accepted. The accepted sample shall be counted in the overall supply quantity. Delay in submission of 4 / 7.

2.0 Bidder have to confirm "Whether OEM catalogue / literature containing the complete technical specifications of the offered Make & Model submitted along with the bid".

3.0 In addition to the above, the bidder must also submit the following test certificates from CPRI/NABL accredited laboratory-

- (ii) Test report for Ingress Protection (IP) of the offered product.
