### B. FINANCIAL

1. The bidder must have annual Financial Turnover from Oper ations equal to **Rs. 20.00** Lakh in any of the preceding 3 (thre e) financial / accounting years reckoned from the original bid c losing date as per the Audited Annual Reports.
