The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

- **4.0** Bidders should note that since this is two packet bid, hence prices should not be disclosed in the techn ical bid otherwise the offer shall be rejected straight-away and no representation for rejection on this ground shall be entertained by OIL.
- **5.0** Bidder to note that in the event of award of order, following timing is also to be noted while delivering the items at OIL's premises as per the delivery schedule mentioned in the tender:

- 6.0 Bidders are required to note that the price quoted by them in the GeM portal is inclusive of all taxes and duties. Since, OIL is eligible for getting concessional GST benefit in line with No tification No. 08/2022 Integrated Tax (Rates) dated 13.07.2022 issued by the Ministry of Finance, Government of India only for order valuing INR 1.00 Lakh and above (excluding taxes), he nce, if it is found that the quoted value is less than INR 1.00 Lakh (excluding taxes), then it would be construed that the bidder has taken actual GST into account in such scenario (since concessional GST is not applicable for such an order valuing less than INR 1.00 Lakh) and OIL will proceed accordingly with placement of order. Any financial implication due to misinterpretation of this clause by the bidder will not be borne by OIL.

- **8.0** Delivery will be at Duliajan and the item should come with proper packing to avoid any transit damage and moisture ingress.
- **9.0** Warranty period shall be as per that mentioned in the item specifications.
- **10.0** The Make and Model of the offered instrument should be clearly mentioned in the offer docu ment. The original product catalogue (from the OEM) of the offered model must accompany the qu otation submitted against this enquiry.

### 16. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

# 17. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

### 18. Generic

Whereever Essentiality Certificate is applicable (PEL/ML), successful bidder should provide Proforma Invoice for processeing for EC application and material should be dispatche after receiving of EC rom DGH. In view of the same, an ATC may be incorporated in GeM, viz, "BIDDER/OEM must provide Proforma Invoice for processeing for EC application within

# 19. Generic
