1.0 SCOPE OF WORK:	
Design, fabrication & supply of Skid mounted cre w Hut fitted with two wooden benches & one des k for resting of Production crew, one door, windo ws in three sides. The hut shall be robust in struc ture & transportable so that it can be transferred from one location to other location depending on requirement. The cr ew hut shall be constructed as per the dimension s of tentative drawing attached herewith.	
2.0 GENERAL DESIGN AND CONSTRUCTION:	
2.1 Main Shell: The main fabrication of the structural framework should be of integral and all welded type to comp rise of the bottom frame, overall framework, slopi ng self-draining roof and desired doors & window s etc. The main corner vertical support posts shall be of 2 inch tubing. All the corner posts shall be s uitably welded at the top with a heavy gauge MS plate which should be able to hold steel forged lifting hooks.	
2.2 Skid: The under structure / base frame of the hut is to be mounted on the skid consisting of 02 (two) no s. of medium beam - ISMB 200 mm x 100 mm hot rolled `I' section. At the end portion of the 'I' section structure on both the sides, Steel Pipe of size 142 mm NB X 9.5 mm W/Thickness should be ins erted & welded properly. Base frame and skid should be made in such a way that no foundation is needed for placement of crew hut.	
2.3 Flooring: The entire flooring of the crew hut shall be of 6 m m thick MS plate, welded lengthwise and breadth wise properly with the base frame of the Skid.	
2.4 Side End Walls: The exterior cladding of the shell shall be of Vertical corrugated pressed steel as per IS. The Corrugated steel sheet shall be of 3 mm thick and shall be welded to the bottom MS channel frame, corner posts, top frame and roof frame. The corrugated version acts as stiffeners and increase strength to weight ratio and eliminates the use of any other vertical supports. All gaps should be sealed at edges and at seams, bottom sills to prevent ingress of insects, moisture etc.	

2.5 Roof:	
The roof shall be of sloping type from the centre t	
owards the walls for efficient drain of rainwater.	
The roof shall be made of 3 mm thick plain MS st	
eel sheets as per IS and is provided with adequat	
ely pressed reinforced sections from inside for ad

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
