Oil India Limited has adopted Purchase Preference policy linked with Local Content issued by MOPNG vide notification no. FP-20013/2/2017-FP-PNG dated 17.11.2020 and the original policy was approved by the Cabinet. This policy is applicable for tender value more than Rs. 1 Crore to treat the local supplier as Class I, Class II and Non Local Supplier and to extend the benefit of purchase preference accordingly as per policy. Since, the estimated value of the subject tender is less than Rs. 1 Crore, no Purchase Preference Policy shall be applicable against this tender.

1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as

defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Financing of trade receivables of Micro and Small Enterprises (MSEs) through Trade Receivables Discounting System (TReDS) platform.

Based on the initiatives of Government of India to help MSE vendors get immediate access to liquid fund b ased on Buyers credit rating by discounting, OIL has registered itself on TReDS platform with M/s RXII, and M/s A TREDS Ltd. (Invoice Mart). MSE vendors can avail this benefit by registering themselves with any of t he exchanges providing e-discounting / electronic factoring services on TReDS platform and following the procedures defined therein, provided OIL is also participating in such TReDS Platform as a Buyer.

- (I) Vendor should be aware that all costs relating to availing the facility of discounting on TReDS platform i ncluding but not limited to Registration charges, Transaction charges for financing, Discounting Charges, I nterest on financing, or any other charges known by any name shall be borne by MSE Vendor.
- (ii) MSE Vendor hereby agrees to indemnify, hold harmless and keep OIL and its affiliates, Directors, offic ers, representatives, agents and employees indemnified, from any and all damages, losses, claims and liab ilities (including legal costs) which may arise from Sellers submission, posting or display, participation, in a ny manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the ter ms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnity bas is.
- (iii) OIL shall not be liable for any special, indirect, punitive, incidental, or consequential damages or any d amages whatsoever (including but not limited to damages for loss of profits or savings, business interrupti on, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.
- (1) Buyer means OIL, who has placed Purchase Order / Contract on a MSE Vendor (Seller).
- (ii) Seller means a MSE vendor, who has been awarded Purchase Order / Contract by OIL, (Buyer).
- 2. Following documents shall be submitted by the bidders along with the bid:
- i. Detailed technical catalogue mentioning the MAKE & MODEL OFFERED.
- ii. Against all flameproof items (Pedestal Fan, Rotary Switch & Cable Gland) bidder must furnish test certificates conforming to the latest version of IS/IEC 60079-0:2011, IS/IEC 60079-0:2007 and IS/IEC 60079-1:200 7 standard from CIMFR (Central Institute of Mining and Fuel Research) or any other NABL (National Accreditation Board for Testing Laboratories, India) accredited Government Laboratory which is not a part of manu facturer's facility along with the offer/bid.
- 3. The items shall be offered with minimum warranty of one year from the date of supply.
- 4. Bidder must be Original Equipment Manufacturer (OEM) or their authorized dealers only. In case of OEM, the bidder should have established office in India in respect of supply and after Sales Service support from India. In case bidder is not OEM of the offered product, a valid dealership certificate from OEM should be enclosed along with the offer.
- 5. Items must be supplied with all required accessories.
- 6. Packing should be adequate to avoid any transit damage or water ingress.

4. Generic

Whereever Essentiality Certificate is applicable (PEL/ML), successful bidder should provide Proforma Invoice for processeing for EC application and material should be dispatche after receiving of EC rom DGH. In view of the same, an ATC may be incorporated in GeM, viz, "BIDDER/OEM must provide Proforma

Invoice for processeing for EC application within

30 days from date of issue of GeM Contract and material should be dispatche after receiving of EC rom DGH."

5. Generic

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
