#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 3. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

#### 4. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

#### 5. Buyer Added Bid Specific ATC

- 1. Packing shall be adequate to avoid any transit damage and water ingression.
- 2. The items shall be delivered at Materials Department, Oil India Ltd., Moran, Assam, India.
- 3. Quoted price should be inclusive of LED lamps & drivers otherwise offer will not be accepted.
- 4. Offer should be complete with catalogue/leaflet/technical literature. Incomplete offer shall be liable for r ejection.

- 7. Light enclosure along with its terminal box shall be of explosion proof (Type Ex-d) suitable for use in oilfi eld hazardous area, Zone-I & Zone-2, and Gas group IIA & II B of oil mines and shall conform to IS/IEC/EN:6 0079-0:2011 & IS/IEC/EN:60079-1:2007.
- 8. Test reports conforming to the above relevant standards from an Indian Government Laboratory or NAB L accredited laboratory or IECEx accredited laboratory or ATEX notified body, which is not a part of manufa cturer's facility; shall be submitted with the quotation as well as with the supply of materials.
- 8.1 Above Test report no. shall be affixed or embossed on each piece of equipment.
- 8.2 Also, Certificates for compliance of relevant Indian Standard for LED luminaries/Driver etc. should be s ent with offer.
