OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

- 1) BID SECURITY: All the Bids must be accompanied by Bid Security for the amount as mentioned in the tender and shall be in the pres cribed format (as per enclosed PROFORMA 1) as Bank Guarantee (BG) (as per enclosed Proforma-D) or Online payment. Bid submitted with un-verified supporting documents shall not be normally considered. 5. Generic

8. Generic

Whereever Essentiality Certificate is applicable (PEL/ML), successful bidder should provide Proforma Invoice for processeing for EC application and material should be dispatche after receiving of EC rom DGH.
