Bidder should categorically confirm compliance while quoting.	Bidder should note that in the event of an order, the API Spec-7.1 certificate for threading and gauging of rotary shouldered connections should be valid, without any break, till execution of purchase order.Bidder to submit valid relevant API Spec-7.1 certificate along with the supply.
