Bids without copies of valid API 8C certificates or with a break in between will be rejected. Additionally, the bidder should also possess API Specification Q1 for manufacturing of Rotary Swivels. Valid copy of API Specification Q1 should be submitted along with the bid, without which the bid will be rejected.
