

CORRIGENDUM

1.0 Amendment No. 2 dated 05.06.2017 to **Tender No. CJG4394P18** has been issued to amend some of the clauses under BEC, SOW , SCC & GCC and also to extend the Bid Closing/Technical Bid Opening Date and Tender Document Sale Date as under :

2.0 The amended clauses are as under -

However, in case the operation is suspended for more than one (1) hour for reasons solely attributable to the Contractor, penalty @ 200% of the Standby Charges/Rental day rate will become payable by the Contractor to Company per hour of delay or part thereof for the entire period of such interruption. Additionally, no charges like standby or operating charges will be payable during the period of haultage/ suspension of work, if the reason of suspension is solely attributable to the Contractor.	Part-3, Section – II (SOW) 7.0 PENALTY: 7.1 Once the equipment, accessories and manpower etc. as per provision of contract are mobilized at site by the Contractor, it is expected that the coring services are carried out without any interruption. Additionally, no charges like standby or operating charges will be payable during the period of haultage/ suspension of work, if the reason of suspension is solely attributable to the Contractor.

Payment shall, however, be made on actual use at well-site against which the unit rates have been asked for. No charges other than indicated above are payable.
- (iv) All taxes, duties and levies excluding Service Tax shall be borne by the Contractor. The quoted price shall be exclusive of Service tax. Service Tax as applicable shall be on Company's account. However, liability for payment of the Service Tax in case of Indian Bidder and overseas Bidder having offices in India shall lie on the Contractor, else in case of Foreign Bidders, the liability shall lie on the Company. The quantum (%age) of Service Tax as applicable against each item must be indicated separately.
- (v) Bid evaluation will be carried out based on the sum total of prices quoted against Item Nos. A, B & C in the Price Bid Format.
