This Corrigendum is issued to notify the following changes:

**1.** Extension of dates:

- Last Date of Bid Submission extended up to **02.06.2020 (11:00 Hrs IST)**
- Last Date of Bid Opening extended up to **02.06.2020 (14:00 Hrs IST)**

**2.** Bidders to take note that as a very special case under the Covid -19 Pandemic situation and declaration of Lockdown issued by Govt. of India, you are not required to submit the original bid bond before the Techno-Commercial bid closing date.
