All documents submitted in physical form should be signed on all pages by the authorized signatory of the bidder and to be submitted in triplicate.

- 5. Bidders must ensure that their bid is uploaded in the system before the tender closing date and time. Also, they must ensure that above documents which are to be submitted in a sealed envelope are also submitted at the above mentioned address before the bid closing date and time failing which the offer shall be rejected.
- 6. Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the bid or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in the rejection of its offer without seeking any clarifications.
- 7. All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) with organisation name as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.

(B) GENERAL NOTES FOR BIDDERS:

- 1. Items shall be Manufactured, Sampled, Tested, Inspected, Marked and Certified as per API Specification 8C and mill inspection certificate thereof should be forwarded along with supply. Bidders to confirm the same while quoting. A copy of valid API Specification 8C certificate must be forwarded along with the offer.
- 2. Markings shall be done as per API Specification 8C i.e. elevators shall be die stamped with manufacturer's name or identification mark, the API monogram and the month and year of manufacture. Bidders are to confirm the same while quoting.
- 3. 'OIL' logo / mark and purchase order number shall be die stamped or paint stencilled on the elevator. Bidders shall confirm compliance to the same while quoting.
- 4. The quotation must accompany relevant catalogue, literature, drawing illustrating all components with part name & part number etc.
- 5. Bidder must forward a list of recommended spares indicating the item, part number, quantity & price for two years successful operation. However, the price of spares will not be considered for evaluation purpose.
- 6. Bidder should indicate the country of origin, port of dispatch of the materials and their best delivery schedule.

(C) SPECIAL NOTES:

1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship &

manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt of the items at site which ever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.

- 2. The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorata calculated and the same will be binding on the bidder.
- 3. Validity of the offers should be 120 days from the date of bid opening. Bids with lesser validity shall be summarily rejected.

- 1. The elevators should feature wear guides / wear bushings. Bidder should confirm the same with documentary evidence.
