BID EVALUATION (BEC)/BID REJECTION CRITERIA (BRC):

The bid must conform to the specifications, terms and conditions given in the tender specifications. Bid will be rejected in case the items offered do not conform to all the required technical parameters stipulated in the technical specifications and to the respective international / national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements shall have to be particularly met by the bidders, without which the offer will be considered as non-responsive and rejected.

(A) TECHNICAL

1. All the non-magnetic drill collars (both Slick & flex) shall be manufactured as per API Spec 7-1 and should meet the technical specifications in toto.

2. All the non-magnetic drill collars (both Slick & flex) shall be ultrasonically inspected and tested for magnetic permeability and hot spots over their entire lengths and test reports / certificates submitted to OIL along with the supply.

3. All the lift plugs shall be ultrasonically inspected over their entire lengths and test reports /certificates submitted to OIL along with the supply.

4. Bidder should meet the experience criteria as indicated below:

In case the bidder is a manufacturer of the offered equipment / item, he should satisfy the following along with documentary evidence, which should be enclosed along with the technical bid.

1.0 Bids are invited under Single Stage Two Bid System. Bidders shall quote accordingly under Single Stage Two Bid System. Please note that no price details should be furnished in the Technical (i.e. Unpriced) bid. The "Unpriced Bid" shall contain all techno-commercial details except the prices which shall be kept blank. 2. The items covered under this enquiry shall be used by OIL in the PEL/ML areas issued/renewed after 01/04/99 and hence, applicable Customs Duty for import of goods shall be ZERO. Indigenous bidders must quote Deemed Export prices. Excise Duty under Deemed Export exempted.
3. All the items will be procured from single source.

12.0 Pre-Despatch / Shipment Inspection & Testing charges, if any, shall be quoted on lumpsum basis separately which shall be considered for commercial evaluation of the offers. However, all to and fro fares, boarding/lodging and other expenses of OIL's Inspection Engineer(s) shall be borne by OIL.

13.0 **Offers received without Integrity Pact duly signed by the authorised signatory of the bidder will be rejected.**

(II) BID EVALUATION CRITERIA (BEC) :

The bids conforming to the specifications, terms and conditions stipulated in the enquiry and considered to be responsive after subjecting to the Bid Rejection Criteria will be considered for further evaluation as per the Bid Evaluation Criteria given below:

A. COMMERCIAL :

- 1.0 All the items will be procured from single source and therefore, offers will be evaluated considering all the four items together.
- 2.0 The evaluation of bids will be done as per the Commercial Bid Format (SUMMARY) detailed vide Para 11.0 of BRC.
- 3.0 If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
