All documents submitted in physical form should be signed on all pages by the authorized signatory of the bidder and to be submitted in triplicate.

- 5. Bidders must ensure that their bid is uploaded in the system before the tender closing date and time. Also, they must ensure that above documents which are to be submitted in a sealed envelope are also submitted at the above mentioned address before the bid closing date and time failing which the offer shall be rejected.
- 6. Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the bid or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in the rejection of its offer without seeking any clarifications.
- 7. All the Bids must be Digitally Signed using "Class 3" digital certificate (*e-commerce application*) with organisation name as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.

#### (B) Special Notes for Bidders:

1. The party shall be preferably a Manufacturer of the equipment. In case the bidder is not a manufacturer, he shall be an authorized representative / dealer / supplier of the equipment of manufacturer. The authorized representative / dealer / supplier shall produce authority letter in original from its manufacturer authorizing them to submit the bid along with the offer.

## 2. Installation / Commissioning & Training:

- a) The successful bidder will be required to install and commission the equipment at Chemical Department, Oil India Ltd., Moran, Assam, India by their competent service engineer (s). The supplier shall replace defective parts if found any, during installation or during the warranty period. This replacement shall be done within a month's time at supplier's cost. The supplier's service engineer must demonstrate the performance of the system as specified in the offer and also must provide training to OIL's technical/scientific staff on operation, application and trouble shooting of the system after installation. Basic instrumentation drawings/ configuration, manuals are to be supplied along with the unit for ready reference.
- b) Installation and Commissioning charges, if any, must be quoted separately on lump sum basis which shall be considered for evaluation of the offer. Offers without indicating the Installation/Commissioning shall be treated as incomplete and non-responsive. Bidders shall confirm about the installation, commissioning while quoting. Any, pre-installation requirements are to be clearly indicated in the offer.

- e) Moreover, if Income/Service taxes are not categorically mentioned in their offer, then such offers shall be loaded with the applicable rate of taxes for evaluation purpose.

#### 3. Annual Maintenance Contract:

- a) The rate for Non Comprehensive AMC for 03(three) years from the date of warranty is over should be quoted with year-wise breakup, which shall be taken into account for evaluation of the bids.
- 4. The bidder shall quote for 2 years spare parts separately which shall not be considered for bid evaluation.
- 5. The system shall be completed in all respect with all other essential accessories required for smooth, efficient running and immediate commissioning after receipt at Moran, Assam.
- 6. The Supplier shall provide Operation manual and maintenance and troubleshooting manual (hard copy as well as soft copies) along with the supply.
- 7. Bidder shall be specific to OIL's requirement and shall offer as per OIL's terms and conditions and requirements. If there is any deviation, bidder shall indicate the deviation clearly with sufficient justification in a separate sheet. Not indicating any deviation by the bidder shall be considered as full acceptance of the OIL's terms and conditions.
- 9. **Payment:** Payment shall be released as follows
  - i) 80% of the order value shall be paid against proof of dispatch/shipment of the goods.
  - ii) Remaining 20% of the order value along with installation and commissioning charges (if any)shall be paid after successful installation and commissioning and acceptance of the unit by OIL.

# (C) General Notes to Bidder's:

1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 12 months from date of successful installation and commissioning at site. In case of breakdown during the warranty

period, a competent service engineer of the supplier shall make as many visits as shall be necessary to rectify the system. The supplier shall provide all spares required for making the system operational. Bidders must confirm the same while quoting.

- 2. Validity of the offers should be 120 days from the date of bid opening. Bids with lesser validity shall be summarily rejected.
- 3. The items covered under this enquiry shall be used by OIL in the PEL/ML areas issued/renewed after 01/04/99 and hence, applicable Customs Duty for import of goods shall be ZERO.
