- 4.0 The tender is invited under SINGLE STAGE-TWO BID SYSTEM. The bidder has to submit both the "TECHNO-COMMERCIAL UNPRICED BID" and "PRICED BID" through electronic form in the OIL's e-Tender portal within the Bid Closing Date and Time stipulated in the e-Tender. The "Techno-commercial Unpriced Bid" shall contain all technical and commercial details except the prices which shall be kept blank. (B) General Notes for Bidders:

- 1.0 The item shall be brand new, unused and prime quality. Bidder shall warrant that the product supplied will be free from all defect & fault in the material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 12 months from date of commissioning of the item, whichever is earlier. The defective materials, if any rejected by us shall be replaced by the supplier at their own expense. Bidder must confirm the same in the quotation.
- 2.0 Quotation must be accompanied with original relevant catalogue / literature and drawing.
- 3.0 Calibration certificate (traceable to NABL or any other recognized calibration agency) shall be submitted by the supplier at the time of delivery.
- 4.0The material supply should be accompanied with test, calibration and warranty /guarantee certificates.
