- 1.0 The tender will be governed by "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders) including Amendments & Addendum to "General Terms & Conditions" for e-Procurement.
- 2.0 Technical and Commercial Check list is furnished vide Annexure B. Please ensure that the check list is properly filled up and uploaded along with Technical bid.
- 3.0 Please note that all tender forms and supporting documents are to be submitted through OIL's e-Procurement site only except following documents which are to be submitted manually in sealed envelope super scribed with tender no. and due date to The Head Materials, Materials Department, Oil India Limited, Duliajan- 786602, Assam on or before the Bid Closing Date and Time mentioned in the Tender.

- 4.0The tender is invited under SINGLE STAGE-TWO BID SYSTEM. The bidder has to submit both the "TECHNO-COMMERCIAL UNPRICED BID" and "PRICED BID" through electronic form in the OIL's e-Tender portal within the Bid Closing Date and Time stipulated in the e-Tender. The "Techno-commercial Unpriced Bid" shall contain all technical and commercial details except the prices which shall be kept blank. Details of prices as per Bid format / Commercial bid to be uploaded as attachment in the Attachment Tab "Notes and Attachments".

Any offer not complying with above submission procedure will be rejected as per Bid Rejection Criteria mentioned in the tender.

- 5.0In Technical Bid opening, only Technical Rfx will be opened. Therefore, the bidder should ensure that "TECHNO-COMMERCIAL UNPRICED BID should contain details as mentioned in the technical specifications as well as BEC/ BRC and upload the same in the Technical RFx Response-> User > Technical Bid. No price should be given in above Technical Rfx otherwise the offer will be rejected. Please go through the help document in details before uploading the document and ensure uploading of technical bid in the Technical RFx Response-> User > Technical Bid only. The "PRICE BID" must contain the price schedule and the bidder's commercial terms and conditions. The bid signed using other than "Class 3" digital certificate, will be liable for rejection.
- 8.0 Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the bid or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in the rejection of its offer without seeking any clarifications.

(B) General Notes to Bidders:

- 1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.
- 2. Threads of the Junk Mill should be manufactured as per API Spec.7-1. The Bidder will have to furnish valid API Spec 7-1 Certificate with the quotation.
- 3. Marking shall be done as per API Spec 7-1, i.e. the Junk Mill should be die-stamped on the OD with the API monogram and the size & style on connection. Additionally, purchase order number should be die stamped along with the name of manufacturer. Bidder should confirm while quoting.
- 4. The Junk Mills should be made from Chromium Molybdenum alloy steel, heat treated and conforming to the requirement of AISI 4130.
- 5. The above Mills should be capable of cutting the toughest fish of alloy steel like packers, bridge plugs, drill pipes, rock bits etc.
- 6. The cutting surface should be of self sharpening type for maximum useful life of the mill.
- 7. Bidders are to indicate recommended brazing flush, welding rods for restoration of hard facing, while quoting.
- 8. The circulation ports should be designed efficiently for to remove the cuttings and simultaneously cooling the cutting surface. Accordingly the bidder will have to confirm the port size in their quotation.
- 9. Thread protectors should be installed.
- 10. The quotation must accompany relevant catalogue, literature, drawing, etc.
- 11.Bidder should indicate the name of manufacturer, country of origin, port of dispatch of the materials along with the quotation.

- 12.Bidder should categorically confirm in the technical bid a delivery schedule within six (06) months, FOB Port of dispatch, after establishment of letter of credit (in case of foreign bidder) or for despatch of the equipment within six (06) months after receipt of formal order (in case of indigenous bidder) failing which their offer will be rejected.
- 13. Any deviation(s) from the tender specification should be clearly highlighted specifying justification in support of deviation.
- 14. Bidders are to quote for all the items as indicated in the NIT.
- 15. Bidder to sign and submit completely filled up Technical check list and Technical Evaluation Matrix for Bid evaluation criteria and Technical specification.
- 16. Bidder should note that in the event of an order the API licenses for manufacturing the manual rig tongs along with authorization for API monogramming should be valid, without any break, till execution of purchase order. Bidder should categorically confirm compliance while quoting.
- 17. Bidder to sign and submit completely filled up Technical check list and Technical Evaluation Matrix for Bid evaluation criteria and Technical specification.

(C) Special Notes:

- 1. The items covered by this enquiry shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Customs Duty during import will be applicable. Indigenous bidder shall be eligible for Deemed Export Benefit against this purchase. Details of Deemed Export are furnished vide Addendum to MM/GLOBAL/E-01/2005 attached. However, Indian bidders will not be issued Recommendatory Letter. In the event of an order on indigenous bidder under deemed export scheme, OIL will issue Project Authority Certificate(PAC) and arrange for DGH Certificate as may be appropriate/applicable. Supplier shall effect dispatch only on receipt of these certificates from OIL, failing which all related liabilities shall be to Supplier's account
- To ascertain the substantial responsiveness of the bid OIL reserves the right to ask the bidder for clarification in respect of clauses covered under BRC also and such clarifications fulfilling the BRC clauses in toto must be received on or before the deadline given by OIL, failing which the offer will be summarily rejected.

BID EVALUATION CRITERIA (BEC)/BID REJECTION CRITERIA (BRC)

The bids shall conform to the specifications and terms as well conditions laid out in the tender. Bids will be rejected in case the items offered do not conform to the required parameters stipulated in the technical specifications and to the respective international / national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms & conditions, particularly the following requirements will have to be met by the bidders, without which, the offer will be considered as non-responsive and shall be rejected.

A. BID EVALUATION CRITERIA (BEC):

A.1 BEC TECHNICAL:

- 1. In case, the bidder is an Original Equipment Manufacturer (OEM):
- 1.1 The bidder should have an experience of minimum 5 (five) years in manufacturing of Hooded/Skirted Junk Mill under API Spec. 7-1 certification (latest edition) preceding the original bid closing date of the tender. Copies of API 7-1 certificates for the last 5 (Five) years (i.e. continuous without having any break in between) shall be submitted along with techno commercial bid. Bids without copies of valid API 7-1 certificates or with break in between will be rejected.
- 1.2.1 The bidder should also have the experience of supplying at least 06 (six) No of Hooded/Skirted Junk Mill of 8.1/8" OD or higher size, to E&P companies / Drilling Contractors / Drilling service providers in the last 5 (five) years as on original bid closing date of the tender (either by them self or through their sole selling agent / distributor / dealer / supply house).

Documentary evidence to substantiate supply record should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as:

- (i) Satisfactory Inspection report (OR)
- (ii) Satisfactory supply completion / Installation / Commissioning report (OR)
- (iii) Delivery challans received by Consignee (OR)
- (iv) Central Excise Gate Pass/ Tax Invoice issued under relevant rules of Central Excise/ VAT

Note:

The Purchase Order date need not be within 5 (five) years preceding original bid closing date of this tender. However, the execution of supply should be within 5 (five) years preceding original bid closing date of this tender.

- 1.2.2 Those Manufacturers which have successfully supplied at least 04 (four) Nos. of Hooded/Skirted Junk Mill of 8.1/8" OD or higher size as specified in Clause No. 1.2.1 to OIL in the last 05 (five) years as on original bid closing date of this tender, either by them self or through their sole selling agent / authorized distributor / authorized dealer / supply house and whose past performance has been satisfactory, they need not satisfy Clause 1.2.1. In this situation the bidder shall have to indicate the Purchase Order (P.O.) number of OIL, date & quantity supplied to OIL in their technical bid.
- 1.3 The bidder shall confirm that the equipment / products will be tested and certified as per API 7-1.

- 1.4 The bidder must keep API licenses along with authorization for API monogram valid till execution of purchase order and must confirm that the offered product will be supplied with API Monogram.
- 1.5 In case renewal process of API license is in progress at the time of bidding, the manufacturer should furnish a letter from API to this effect that renewal of the license is under examination with API and is authorized to manufacture the items as per API license and to use API monogram till the renewal for license is issued. The bidder shall also submit an undertaking that delay in renewal of API certificate shall not affect the stipulated delivery schedule of the tender / purchase order.
- 1.6 Bidder quoted as manufacturer must guarantee uninterrupted supply of spares and availability of service for at least 10 years with effect from delivery of the Item / product for the item / product to be supplied under the Tender / Order, if order is awarded to them by OIL.
- 1.7 Bidder should categorically confirm in the technical bid a delivery schedule within six (06) months, FOB Port of dispatch, after establishment of letter of credit (in case of foreign bidder) or for despatch of the equipment within six (06) months after receipt of formal order (in case of indigenous bidder) failing which their offer will be rejected.
- 2. In case the bidder is sole selling agent / distributor / dealer / supply house of any API approved Original Equipment manufacturer (OEM), then bidder must furnish the following documents:
- 2.1 (a) Authorization certificate cum warranty backup from the manufacturer (in original on manufacturer's letter head) should be submitted along with the offer. This certificate should be valid at the time of bidding and should remain valid during the entire execution period of the order.
- 2.1 (b) Undertaking from the manufacturer (in original on manufacturer's letter head) guaranteeing supply of items to the bidder in the event of an order on the bidder should be submitted along with the offer. This certificate should be valid at the time of bidding and should remain valid during the entire execution period of the order.
- 2.2 The bidder must also submit an undertaking in original from the manufacturer for back up guarantee, after-sales services and uninterrupted supply of spares for at least 10 years with effect from delivery of the Item / product for the item / product to be supplied under the Tender / Order, if order is awarded to them by OIL.
- 2.3 Copies of valid API Spec 7-1 certificates of the OEM of their quoted product in line with para 1.1 above.
- 2.4.1 The bidder should additionally have the experience of supplying at least 06 (Six) Nos. of Hooded/Skirted Junk Mill of 8.1/8" OD or higher size, to E&P companies / Drilling Contractors / Drilling service providers in the last 5 (five) years as on original bid closing date of the tender.

Documentary evidence to substantiate supply record should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as:

- 2.4.2 Those bidders which have successfully supplied 04 (four) No of Hooded/Skirted Junk Mill of 8.1/8" OD or higher size as specified in Clause No. 2.4.1 to OIL in the last 05 (five) years, preceding the original bid closing date of this tender and whose past performance has been satisfactory, they need not satisfy Clause 2.4.1. In this situation the bidder shall have to indicate the Purchase Order (P.O.) number of OIL, date & quantity supplied to OIL in their technical bid. However, this exemption shall be applicable only if the bidder has declared in the bid that they will be supplying the tendered item from the same manufacturer as per the last order supply.
- 2.5 The sole selling agent / distributor / dealer / supply house of any Original Equipment manufacturers should quote for the supply of Hooded/Skirted Junk Mill from the manufacturers who meet the experience & other criteria as mentioned at clauses 1.1, 1.2.1 or 1.2.2, 1.3, 1.4 & 1.5 above. The bidder is required to submit documentary evidence in respect of the above from the concerned manufacturer along with the techno-commercial bid.
- 2.6 Bidder should categorically confirm in the technical bid a delivery schedule within six (06) months, FOB Port of dispatch, after establishment of letter of credit (in case of foreign bidder) or for despatch of the equipment within six (06) months after receipt of formal order (in case of indigenous bidder) failing which their offer will be rejected.

Financial Criteria:

- Annual Turnover: The bidder shall have an annual financial turnover of minimum US\$ 72,754.00 or Rs 50,20,000.00 during any of the preceding 03 (three) financial years reckoned from the original bid closing date of the tender.
- 2.0 "Net Worth" of the bidder should be positive for the financial/accounting year just preceding to the Bid Closing Date of the Tender.
- 3.0 Considering the time required for preparation of Financial Statements, if the last date of preceding financial / accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial / accounting year are not available with the bidder, then the financial turnover of the previous three financial / accounting years excluding the preceding financial / accounting year will be considered.  Bidder not complying with above submission procedure will be rejected.
- 2.0 Bid security of INR 200,000.00 or US\$ 2,900.00 shall be furnished as a part of the TECHNICAL BID. Any bid not accompanied by a proper bid security in ORIGINAL will be rejected without any further consideration. A bid shall be rejected straightway if Original Bid Security is not received within the stipulated date & time mentioned in the Tender and/or if the Bid Security validity is shorter than the validity indicated in Tender and/or if the Bid Security amount is lesser than the amount indicated in the Tender.
