(A) General Notes for e-tender :

- 1. The tender will be governed by "General Terms & Conditions" for e-Procurement as per Booklet No.MM/GLOBAL/E-01/2005 for E-procurement(ICB Tenders) including Amendment and Addendum.
- 2. The general details of tender can be viewed by opening the RFx [Tender] under RFx and Auctions. The details of items tendered can be found in the Item Data and details uploaded under Technical RFX.
- 3. Bid must be submitted electronically only through OIL's e-procurement portal. Bid submitted in any other form will be rejected.
- 4. Please note that all tender forms and supporting documents are to be submitted through OIL's e-Procurement site only except following documents which are to be submitted manually in sealed envelope super scribed with tender no. and due date to The **Head Materials**, **Materials Department**, **Oil**

India Limited, **Duliajan- 786602**, **Assam** on or before the Bid Closing Date and Time mentioned in the Tender.

- b) Details Catalogue and any other document which have been specified to be submitted in original.

All documents submitted in physical form should be signed on all pages by the authorized signatory of the bidder and to be submitted in triplicate.

- 5. Bidders must ensure that their bid is uploaded in the system before the tender closing date and time. Also, they must ensure that above documents which are to be submitted in a sealed envelope are also submitted at the above mentioned address before the bid closing date and time failing which the offer shall be rejected.
- 6. Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the bid or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in the rejection of its offer without seeking any clarifications.
- 7. All the Bids must be Digitally Signed using "Class 3" digital certificate (*e-commerce application*) with organisation name as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.

(B) GENERAL NOTES FOR BIDDERS:

- 1) The Bidder shall confirm in their technical bid about compliance of all the points under technical specification and notes of the tender.
- 2) The Bidder shall submit the relevant drawing and literature along with technical bid as given below-
- a. Cross Sectional Drawing showing major dimensions.
- b. Product Catalogue.
- 3) Each item shall bear markings on name plate as follows:
- a. API Monogram
- b. OIL's purchase order no.
- c. equipment serial number
- d. Manufacturer's name
- e. rated working pressure, bore size
- f. material of construction, PSL, PR, & Trim designation.
- g. year of manufacture

In addition to above, followings shall be embossed permanently on the body of each valve:

- a. API Monogram
- b. OIL's purchase order no.
- c. equipment serial number
- d. manufacturer's name
- e. rated working pressure & bore size

4) THIRD PARTY INSPECTION:

The valves will be inspected by M/s OIL approved Third Party Inspection Agency viz M/s Lloyds or M/s Bureau Veritas or RITES or M/s IRS or M/s DNV only. Third Party Inspection charges to be quoted separately which

will be considered for bid evaluation. Quotation received without TPI charges will be loaded with the maximum TPI charges received against this tender at the time of commercial evaluation. The scope of Third Party Inspection will be as under:-

- a. General Design,
- b. Material,
- c. Welding (if any),
- d. Quality Control,
- e. Equipment Marking,
- f. Storing, packaging & shipping,
- g. Radiography /ultrasonic test, wherever applicable,
- h. any other aspects found necessary by TPIA.
- 5) The TPI report shall be submitted along with the material supply.

(C) <u>SPECIAL NOTES</u>:

- 1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt of the items at site whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.
- 2. The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorata calculated and the same will be binding on the bidder.
- 3. Validity of the offers should be 120 days from the date of bid opening. Bids with lesser validity shall be straightway rejected.
- 4. The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Customs Duty during import will be applicable. Indigenous bidder shall be eligible for Deemed Export Benefit against this purchase. Details of Deemed Export are furnished vide Addendum to MM/GLOBAL/01/2005 enclosed. However no Recommendatory letters will be issued to Indian Bidders.
- 5. Commercial Check-List vide Annexure-B shall be filled-up and submitted along with the offer.
- 6. To ascertain the substantial responsiveness of the bid OIL reserves the right to ask the bidder for clarification in respect of clauses covered under BRC also and such clarifications fulfilling the BRC clauses in toto must be received on or before the deadline given by the company, failing which the offer will be summarily rejected.
- 7. Other terms and conditions of the tender shall be as per "General Terms & Conditions" for e- Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders). BID REJECTION CRITERIA (BRC)/BID EVALUATION CRITERIA (BEC)

(I) BID REJECTION CRITERIA (TECHNICAL)

(A) TECHNICAL

The bids shall in general conform to the specifications and terms and conditions given in the tender. Bids shall be rejected in case the goods offered do not conform to the required minimum/maximum parameters stipulated in the technical specifications and to the respective international/national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the bids, without which the same will be considered as non-responsive and be rejected.

In addition to BRC criteria vide SECTION – 'D' of General Terms and Conditions for Global Tender (MM/GLOBAL/E01/2005), the following BRC criteria will be applicable against this tender:

1.0 Bidder's Qualification

1.1 The bidder shall be an original equipment manufacturer (OEM) of API 6 A Gate Valves having API 6A certificate with continuous validity for last 05 years from original bid closing date of this tender. Necessary API 6A certificate to be submitted by the bidder.

OR

- 1.2 The bidder shall be an authorized dealer / authorized distributor of an original equipment manufacturer (OEM) of API 6A Gate Valves having API 6A certificate with continuous validity for last 05 years from original bid closing date of this tender. Necessary API 6A certificate to be submitted by the bidder.
- 1.3 In case the bidder is an authorized dealer / authorized distributor, a valid copy of authorization letter / dealership certificate with proper guarantee/warranty back up on the supplied products from the OEM (the principal) shall be submitted by the bidder.

2.0 Bidder's Experience

- 2.1 In case the bidder is an Original Equipment Manufacturer (OEM),
 - 2.1.1 The bidder (OEM) shall have credential of successful execution of order(s) for API 6A Gate valves, fulfilling all of the following criteria
 - (a) for not less than 30% of the tender quantity, (rounded off to the nearest lower integer),
 - (b) of same or higher size and same or higher pressure rating indicated in the tender,
 - (c) in last 03 years from the original bid closing date of the tender,
 - (d) to any Oil & Gas Industry.
- 2.2 In case the bidder is an authorized dealer / distributor of OEM,
 - 2.2.1 The principal (OEM) shall meet the experience criteria stipulated in para 2.1.1.
 - 2.2.2 The bidder (authorized dealer/ distributor) shall have credential of successful execution of order(s) for API 6A Gate valves, fulfilling all of the following criteria
 - (a) for not less than 30% of the tender quantity, (rounded off to the nearest lower integer),
 - (b) of same or higher size and same or higher pressure rating indicated in the tender,

- (c) in last 03 years from the original bid closing date of the tender,
- (d) to any Oil & Gas Industry.

(B) COMMERCIAL:

- 1. Commercial Bid Rejection Criteria will be as per Section-D of General Terms & Conditions of Global Tender (MM/GLOBAL/E-01/2005) with following Special Bid Rejection Criteria. Bids are invited under Single Stage Composite Bid System. Bidders shall quote accordingly under Single Stage Composite Bid System.
- 2.0 Bid security of US \$ 1,450.00 or Rs. 93,300.00 shall be furnished as a part of the TECHNICAL BID (refer Clause Nos.9.0 & 12.0 (Section A) of "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders)). Any bid not accompanied by a proper bid security in ORIGINAL will be rejected without any further consideration. A bid shall be rejected straightway if Original Bid Security is not received within the stipulated date & time mentioned in the Tender and/or if the Bid Security validity is shorter than the validity indicated in Tender and/or if the Bid Security amount indicated in the Tender.
- 2.1 For exemption for submission of Bid Security, please refer Clause No. 9.8 (Section A) of "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders).
- 2.2 The Bank Guarantee towards Bid Security shall be valid upto 04.06.2016.
- 3. Validity of the bid shall be minimum 120 days from the date of Bid Closing Date. Bids with lesser validity will be straightway rejected.
- 4. Bidders must confirm that Goods, materials or plant(s) to be supplied shall be new of recent make and of the best quality and workmanship and shall be guaranteed for a period of 18 months from the date of shipment/dispatch or twelve (12) months from the date of receipt of the items at site, whichever is earlier against any defects arising from faulty materials, workmanship or design. Defective goods/materials or parts rejected by OIL shall be replaced immediately by the supplier at the supplier's expenses at no extra cost to OIL.

- 5. Successful bidder will be required to furnish a Performance Bank Guarantee @10% of the order value. The Performance Bank Guarantee must be valid for 12 (twelve) months from the date of receipt/acceptance of goods or 18 months from the date of shipment/despatch. Bidder must confirm the same in their Technical Bid. Offers not complying with this clause will be rejected.

NOTE:
