(A) General Notes for e-tender :

- 1. The tender will be governed by "General Terms & Conditions" for e-Procurement as per Booklet No.MM/GLOBAL/E-01/2005 for E-procurement(ICB Tenders) including Amendment and Addendum.
- 2. The general details of tender can be viewed by opening the RFx [Tender] under RFx and Auctions. The details of items tendered can be found in the Item Data and details uploaded under Technical RFX.

- 3. Bid must be submitted electronically only through OIL's e-procurement portal. Bid submitted in any other form will be rejected.
- 4. Please note that all tender forms and supporting documents are to be submitted through OIL's e-Procurement site only except following documents which are to be submitted manually in sealed envelope super scribed with tender no. and due date to The Head Materials, Materials Department, Oil India Limited, Duliajan- 786602, Assam on or before the Bid Closing Date and Time mentioned in the Tender
 - a) Original Bid Security along with two duplicate copies of Bid Security
 - b) <u>Details Catalogue and any other document which have been specified to be submitted in original.</u>

All documents submitted in physical form should be signed on all pages by the authorized signatory of the bidder and to be submitted in triplicate.

- 5. Bidders must ensure that their bid is uploaded in the system before the tender closing date and time. Also, they must ensure that above documents which are to be submitted in a sealed envelope are also submitted at the above mentioned address before the bid closing date and time failing which the offer shall be rejected.
- 6. Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the bid or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in the rejection of its offer without seeking any clarifications.
- 7. All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) with organisation name as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.
- 8. Please do refer the User Manual provided on the portal on the procedure How to create Response for submitting offer.

(B) GENERAL NOTES FOR BIDDERS:

- 1. The Scissor lift Table should be provided with Detachable Type Railings on Length & Wide side.
- 2. The Scissor lift Table should be provided with complete flame proof AC Power pack Unit with minimum 15 meter long wire
- 3. The Scissor lift Table should be equipped with emergency stop and emergency lowering.
- 4. The Scissor lift Table should be provided with limit switch for raised height.
- 5. The Scissor lift Table should be provided with out riggers jacks for stability.
- 6. The Scissor lift Table should be equipped with Flow Control Valve for speed reduction during lowering.
- 7. The Scissor lift Table should be both Remote operated and Control panel operated for both up and down movement.
- 8. The items shall be brand new, unused & in ready to use condition. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18

months from date of receipt at site or 12 months from date of Commissioning whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.

- 9. Bidders should indicate the country of origin and port of dispatch of the materials and their best delivery schedule.
- 10. Bidder should forward technical literature, catalogue, drawings with exploded views of each & every item, and a 02 year recommended spare parts list indicating part names & part numbers.
- 11. Purchase order number and manufacturer's names have to be die stamped on the items.
- 12. Bidder, if not a manufacturer, must submit a letter of authorization along with the quotation to sell their products to OIL INDIA LIMITED from the original manufacturer with warranty back-up and assurance to make spares available for at least next 10 years
- 13. Bidders should categorically confirm compliance of their offers to all the above points while quoting.
- 14. Installation and Commissioning:
- (i) The successful bidder will be required to install and commission the equipment by their competent personnel at OIL's designated drill site in Duliajan, Assam, India, The bidder shall have to provide training to OIL personnel during Installation & Commissioning of the units. Commissioning shall be completed within 2(two) months after receipt of all the items at Duliajan
- (ii) Installation and Commissioning charges, if any, must be quoted separately on lump sum basis which shall be considered for evaluation of the offer. Offers without indicating the Installation/Commissioning shall be treated as incomplete and non-responsive. Bidders shall confirm about the installation, commissioning while quoting. Any, pre-installation requirements are to be clearly indicated in the offer.
- (iii) While quoting installation and commissioning charges, bidder should take into account all charges including to and fro fares, boarding/lodging, and other daily expenses of the commissioning personnel. OIL may provide accommodation on chargeable basis subject to availability. Income, Service, Corporate Taxes etc., if any, towards Installation/Commissioning will be to supplier's account and will be deducted at source.
- (iv)Offers without indicating the Installation/Commissioning charges shall be loaded with the maximum installation/commissioning charges received against this tender for evaluation purpose.
- (v) Moreover, if Income/Service taxes are not categorically mentioned in their offer, then such offers shall be loaded with the applicable rate of taxes for evaluation purpose.

(C) SPECIAL NOTES:

- 1. The items covered by this tender shall not be eligible for NIL Custom Duty benefit/deemed export benefit. Hence the bidders should quote their non-deemed export benefit prices.
- 2. Technical and Commercial Check-List vide **Annexure-B** shall be filled-up and submitted along with the offer.

- 3. To ascertain the substantial responsiveness of the bid OIL reserves the right to ask the bidder for clarification in respect of clauses covered under BRC also and such clarifications fulfilling the BRC clauses in to to must be received on or before the deadline given by the company, failing which the offer will be summarily rejected.
- 4. Other terms and conditions of the tender shall be as per "General Terms & Conditions" for e- Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders). However, if any of the Clauses of the Bid Rejection Criteria (BRC) / Bid Evaluation Criteria (BEC) mentioned here contradict the Clauses in the "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders) of the tender and/or elsewhere, those mentioned in this BEC / BRC shall prevail.

BID REJECTION CRITERIA (BRC)/BID EVALUATION CRITERIA (BEC)

(I) BID REJECTION CRITERIA:

(A) TECHNICAL

The bids shall in general conform to the specifications and terms and conditions given in the tender. Bids shall be rejected in case the goods offered do not conform to the required minimum/maximum parameters stipulated in the technical specifications and to the respective international /national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the bids, without which the same will be considered as non-responsive and be rejected.

- 1.0 Manufacturing Experience: In case the bidder is a manufacturer of the offered equipment/item, he should satisfy the following along with documentary evidences, which should be enclosed along with the techno-commercial bid.
- A). Minimum 3 years continuous experience of manufacturing of tendered item. For this purpose, the period reckoned shall be from the original bid closing date of the tender. Documentary evidence in respect of the manufacturing experience criteria should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as:
- (i) Satisfactory Inspection report (OR)
- (ii) Satisfactory supply completion/ Installation / Commissioning report (OR)
- (iii) Delivery challans received by Consignee (OR)
- (iv) Central Excise Gate Pass/ Tax Invoice issued under relevant rules of Central Excise/ VAT Note: Order copy to be enclosed with relevant page no. bearing signature of purchaser or authenticated by purchaser.
- 2.0 In case the bidder is a sole selling agents/authorized distributors/authorized dealers/authorized supply houses, then the bidder is required to submit documentary evidence in respect of the above 1(A) from the concerned manufacturer (having supplied such items either by manufacturer themself or their distributor) along with the techno-commercial bid.
- 3.0 In case the bidder is a sole selling agents/authorized distributors/authorized dealers/authorized supply houses, then the bidder must submit a letter of authorization along with the quotation to sell their products to OIL INDIA LIMITED from the original manufacture with warranty back-up and assurance to make spares available for at least the next 10 years.

(B) <u>COMMERCIAL:</u>

- Commercial Bid Rejection Criteria will be as per Section-D of General Terms & Conditions of Global Tender (MM/GLOBAL/E-01/2005) with following Special Bid Rejection Criteria. Bids are invited under Single Stage Composite Bid System. Bidders shall quote accordingly under Single Stage Composite Bid System.
- 2.0 **Bid security of US \$ 920.00 or INR 60,000.00** shall be furnished as a part of the TECHNICAL BID (refer

Clause Nos.9.0 & 12.0 (Section A) of "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders)). A bid shall be rejected straightway if Original Bid Security is not received within the stipulated date & time mentioned in the Tender and/or if the Bid Security validity is shorter than the validity indicated in Tender and/or if the Bid Security amount is lesser than the amount indicated in the Tender.

- 2.1 For exemption for submission of Bid Security, please refer Clause No. 9.8 (Section A) of "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders).
- 2.2 The Bank Guarantee towards Bid Security shall be valid upto **05.11.2016**.
- 3. Validity of the bid shall be minimum 120 days from the date of Bid Closing Date. Bids with lesser validity will be straightway rejected.
- 4. Bidders must confirm that Goods, materials or plant(s) to be supplied shall be new of recent make and of the best quality and workmanship and shall be guaranteed for a period of 18 months from the date of shipment/dispatch or twelve(12) months from the date of Commissioning, whichever is earlier against any defects arising from faulty materials, workmanship or design. Defective goods/materials or parts rejected by OIL shall be replaced immediately by the supplier at the supplier's expenses at no extra cost to OIL.
- 5. Successful bidder will be required to furnish a Performance Bank Guarantee @10% of the order value. The Performance Bank Guarantee must be valid for 12 (twelve) months from the date of installation/commissioning. Bidder must confirm the same in their Technical Bid. Offers not complying with this clause will be rejected.
