- 1.0 The tender will be governed by "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005 for E-procurement (ICB Tenders) including Amendments & Addendum to "General Terms & Conditions" for e-Procurement.
- 2.0 Check list is furnished vide Annexure C. Please ensure that the check list is properly filled up and uploaded along with Technical bid.
- 3.0 Please note that all tender forms and supporting documents are to be submitted through OIL's e-Procurement site only except following documents which are to be submitted manually in sealed envelope super scribed with tender no. and due date to **The Head Materials, Materials Department, Oil India Limited, Duliajan- 786602, Assam on or before the Bid Closing Date and Time mentioned in the Tender.**

- 4.0 The tender is invited under SINGLE STAGE-TWO BID SYSTEM. The bidder has to submit both the "TECHNO-COMMERCIAL UNPRICED BID" and "PRICED BID" through electronic form in the OIL's e-Tender portal within the Bid Closing Date and Time stipulated in the e-Tender. The "Techno-commercial

Unpriced Bid" shall contain all technical and commercial details except the prices which shall be kept blank. Details of prices as per Bid format/Commercial bid to be uploaded as attachment in the Attachment Tab "Notes and Attachments".

Any offer not complying with above submission procedure will be rejected as per Bid Rejection Criteria mentioned in the tender.

- 5.0 In Technical Bid opening, only Technical Rfx will be opened. Therefore, the bidder should ensure that "TECHNO-COMMERCIAL UNPRICED BID should contain details as mentioned in the technical specifications as well as BEC/ BRC and upload the same in the Technical Rfx Response-> User > Technical Bid. No price should be given in above Technical Rfx otherwise the offer will be rejected. The "PRICE BID" must contain the price schedule and the bidder's commercial terms and conditions. Failure to furnish all information required as per the bid or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in the rejection of its offer without seeking any clarifications.

# **NOTES FOR BIDDERS:**

- 1. The units should be suitable for high pressure testing of the BOP Stacks, Choke and Kill Lines, Choke and Kill manifolds & any other equipment requiring high pressure static testing.
- 2. The unit should be portable preferably wheel mounted & complete with Chart Recorder.
- 3. The unit should be suitable for operation using plain water / water with soluble oil mixture.
- 4. The unit should be in ready to use condition.
- 5. Bidder should forward relevant Catalogue, Drawing, and Literature of quoted item along with the quotation.
- 6. Bidder should forward a list of recommended spares for 2 year operation indicating part nos., quantity & unit price separately.
- 7. Bidder should confirm that the units (in the event of an order) shall be brand new, unused & free from any defect
- 8. Bidder should indicate the name of manufacturer & country of origin.
- 9. Bidder should indicate the dimensions of unit including the weight while quoting.
- 10. The items shall be brand new, unused & of prime quality. #### 11. Installation and commissioning:

- (i) The bidder must install and commission the equipment at Oil India Limited, Duliajan, Assam, India, Pin Code: 786602 so as to achieve complete functionality as per scope of work. The supplier should replace defective parts if found any, during installation or during the warranty period. This replacement should be done at supplier's cost. The bidder must also demonstrate operation / functioning of the equipment and facilitate understanding the operation of the equipment to OIL personnel, at the time of installation and commissioning of the equipment..
- (ii) Installation and Commissioning charges, if any, must be quoted separately on lump sum basis which shall be considered for evaluation of the offer. Offers without indicating the Installation/Commissioning shall be treated as incomplete and non-responsive. Bidders shall confirm about the installation, commissioning while quoting. Any, pre-installation requirements are to be clearly indicated in the offer.

# **13.0 Payment:** Payment shall be released as follows

#### TECHNICAL SPECIFICATION OF HIGH PRESSURE PORTABLE TEST UNIT

PNEUMATIC OPERATED, PORTABLE, WHEEL MOUNTED, LIGHT WEIGHT, HYDRO-STATIC PRESSURE TEST UNIT WITH CHART RECORDER & ALL REQUIRED ACCESSORIES SUITABLE FOR TESTING UPTO 703 KG/SQ.CM. (10000 PSI).

The unit should consists of following:

- 1. Air driven hydraulic pump capable of producing a minimum of 703 Kg/Sq.Cm. (10000 psi) output with 7 Kg./Sq.Cm (100 psi) air supply.
- 2. Adjustable air regulator from 0-10.5 Kg/Sq.Cm. (0-150 PSI) to limit hydraulic output with suitable air on-off valve.
- 3. Air filter & lubricator assembly.
- 4. Safety relief valve to protect the test unit against over pressurizing
