Special Notes: AA. COMMON NOTES:

- 1. Item 10 and 20 are explosives items and falls under negative list of import. So, necessary DGCA landing Permit/explosive import License from the competent authority is required to be otained for Air freighting/Importing to Kolkata/Delhi/Mumbai, India. Hence, the Bidder must quote with IATA classification and UN Number of all the Explosive items for AIR FREIGHTING.
- 2. Item No.: 10 (Hollow Steel Carrier Charge) should be compatible to be used with 4" Dia. HSC (PORTED Hollow Steel Carrier) GUN, 4 spf, 60/90/120 Deg phase (P.N: HSC-4000-005 of JRC or equivalent). The bidder must confirm the same.
- **3.** The offers must meet all the tech. specification mentioned against each item in NIT or else bids will be rejected.
- **4.** The Bidder must confirm that the offered Explosives items (SI. 10 & 20) will perform as per its API standard and the technical specifications mentioned in the tender document. MSDS (Material Safety Data Sheet) for all the Explosive items is required to be submitted with the offer by Bidders.

- 7.(b) In case, more than one such technically acceptable bidders, whose products have not been field proven in Oil India Limited, offer a price lower than the bidder, whose product is field proven in Oil India Limited, the Company may place trial orders on all such bidders by distributing the 25% (maximum) amongst them subject to other bidders matching the price offered by the lowest technically acceptable bidder. In the event of other bidders (other than the lowest bidder), whose products have not been field proven in Oil India Limited, decline to match the price as stated above, only the lowest bidder will be eligible for the trial order. - 4) The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Custom Duty during import will be applicable. Indigenous bidder shall be eligible for Deemed Export Benefit against this purchase. Details of Deemed Export are furnished vide Addendum to MM/GLOBAL/01/2005 enclosed.
- 5) All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) only as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India. a. TECHNICAL

The bids shall broadly conform to the specifications and terms and conditions given in this bid document. Bids shall be rejected in case the items offered do not conform to required parameters stipulated in the technical specifications and to the respective international/national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected.

- 1. Experience:
- A. MANUFACTURERS EXPERIENCE: IN CASE THE BIDDER IS THE MANUFACTURER

If the bidder is the original manufacturer of the offered item(s), then they must satisfy the following criteria for manufacturing and supply experience and furnish the relevant documentary evidences as per below along with technical bid:

- I) They must have an experience of minimum 05 (Five) years in manufacturing the quoted items as on the original bid closing date of the tender. The bidder must provide firm confirmation regarding this in its bid.
- II) The bidder should have experience of successfully executing at least 1(one) order for minimum 50% quantity each (to be rounded to next higher whole figure) of the tendered item nos. 10 & 20 to any E & P companies /Logging service provider during last 05 (Five) years as on original bid closing date of the tender. Documentary evidence in respect of manufacturing and supplying the above mentioned items should be submitted with the technical bid, in the form of copies of relevant Purchase Orders (PO date should be within the last 05 years) along with copies of any of the following documents in respect of satisfactory execution of each of those Purchase Orders failing which the bids will be rejected:

- i) Satisfactory Inspection Report (OR)

B) IN CASE THE BIDDER IS NOT AN ORIGINAL MANUFACTURER

If the bidder is not an original manufacturer, then bidder must furnish the following documents along with the technical bid failing which the bids will be rejected:

- I) The bidder must have authorisation letter from OEM along with the bid to quote against the tender.
- II) The manufacturer (OEM) shall fulfil the experience criteria mentioned in the clause no. 1.A. (I) & (II) above.
- III) Additionally, the bidder should have supplied minimum 50% quantity each (to be rounded to next higher whole figure) of the tendered item nos. 10 & 20 to any E & P companies /Logging service provider during last 05 (Five) years as on original bid closing date of the tender. Documentary evidence in respect of manufacturing and supplying the above mentioned items should be submitted with the technical bid, in the form of copies of relevant Purchase Orders (PO date should be within the last 05 years) along with copies of any of the following documents in respect of satisfactory execution of each of those Purchase Orders failing which the bids will be rejected:

- 2. The bidder must submit firm confirmation/certificate along with the bid declaring that the bidder or the OEM (in case the bidder is not the OEM) possesses all required manufacturing, testing and quality control facilities for the quoted items.
- 3. All materials as indicated in the material description of the tender should be offered. If any of the items are not offered by the bidder, the bid will not be considered for evaluation. Bid evaluation will be done only for those bids which offer full quantities of goods as mentioned in the Tender document.

5.0 FINANCIAL EVALUATION CRITERIA:

- 5.1 The bidder shall have an annual financial turnover of minimum Rs. 12,68,177.13 or equivalent during any of the preceding 03 (Three) financial years reckoned from the original bid closing date.
- 5.2 "Net Worth" of the bidder should be positive for the preceding financial/accounting year.
- 5.3 Considering the time required for preparation of Financial Statements, if the last date of preceding financial / accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial / accounting year are not available with the bidder, then the financial turnover of the previous three financial / accounting years excluding the preceding financial / accounting year will be considered. In such cases, the Net worth of the previous financial / accounting year excluding the preceding financial / accounting year will be considered. However, the bidder has to submit an affidavit/undertaking certifying that 'the balance sheet/Financial Statements for the financial year 2016-17(as the case may be) has actually not been audited so far'.

Note: For proof of Annual Turnover & Net worth any one of the following document must be submitted along with the bid:-

i) A certificate issued by a practicing Chartered Cost Accountant (with Membership Number and Firm Registration Number), certifying the Annual turnover & Net worth as per format prescribed in ANNEXURE.

- ii) Audited Balance Sheet along with Profit & Loss account. In case of foreign bidders, self-attested/digitally signed printed published accounts are also acceptable.
- 5.4 In case the Audited Balance Sheet and Profit & Loss Account submitted along with the bid are in currencies other than INR or US\$, the bidder shall have to convert the figures in equivalent INR or US\$ considering the prevailing conversion rate on the date on which the Audited Balance Sheet and Profit & Loss Account is signed. A CA certificate is to be submitted by the bidder regarding converted figures in equivalent INR or US\$.

6.0 DELIVERY:

The bidder should categorically confirm in the technical bid that the tendered items will be supplied within the delivery period if mentioned in the tender, without which the bid will be rejected.

b. COMMERCIAL

- 1.0 Bids are invited under Single Stage Composite Bid System. Bidders shall quote accordingly.
- 2.0 Validity of the bid shall be minimum 90 days from the date of Bid closing Date. Bids with lesser validity will be rejected.
