- b) The API `RP-43' or `RP- 19-B'data sheet for Item No:10 must be submitted with the bid and it must be signed and stamped by API Inspector/officials.
- c) At least equal number of DETO CORD/CHARGE CLIPS, if required, must be supplied with the Charges.

So, necessary DGCA landing Permit/explosive import License from the competent authority is required to be obtained for Air freighting/Importing to Kolkata /Delhi/Mumbai, India. Hence the Bidder must quote with IATA classification and UN Number of all the Explosive items for AIR FREIGHTING.
- **8.** Bidder must provide their response to the Technical Check list(Annexure-A)& BEC/BRC Chek list(Annexure-B) alongwith the Bid.

- 3. Bid must be submitted electronically only through OIL's e-procurement portal. Bid submitted in any other form will be rejected.
- 4. The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Custom Duty during import will be applicable. Indigenous bidder shall be eligible for Deemed Export Benefit against this purchase. Details of Deemed Export are furnished vide Addendum to MM/GLOBAL/01/2005 enclosed.
- 5. All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) only as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India. Considering the time required for preparation of Financial Statements, if the last date of preceding financial / accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial / accounting year are not available with the bidder, then the financial turnover of the previous three financial / accounting years excluding the preceding financial / accounting year will be considered. In such cases, the Net worth of the previous financial / accounting year excluding the preceding financial / accounting year will be considered. - 3.0 The original bid security (Amount is mentioned above and also in RFX Information'RFX Parameters of the tender in OIL's e-portal) should reach us before bid closing date and time of the technical bid. Any bid not accompanied by a proper bid security in ORIGINAL will be rejected without any further consideration. The bidders who are exempted from submitting the Bid Bond should attach documentary evidence in Technical RFx as per clause 9.8 (Section A) of General Terms and conditions for Global Tender (MM/GLOBAL/E-01/2005). The bid security shall be valid up to 10.04.2017. Please submit bid bond as per revised format (with two duplicate copies)
