OIL invites Bids for the supply of **Casing Head Housing & Assembly**. through its e-Procurement site under **International Competitive Bidding (ICB)** - **SINGLE STAGE COMPOSITE BID System**. The bidding documents and other terms and conditions are available at Booklet No. MM/GLOBAL/E-01/2005-July2012. The prescribed Bid Forms for submission of bids are available in the tender document folder.

The general details of tender can be viewed by opening the RFx [Tender no.] under RFx and Auctions page. The details of items tendered can be found under Item tab and details can be found under Technical RFX.

The tender is invited with firm price for the specified quantity. Further details of tender are given in Technical Rfx -> External Area - > Tender Documents as **ANNEXURE 1A**.

The tender will be governed by:

- a) "General Terms & Conditions" for e-Procurement as per Booklet No. MM/GLOBAL/E-01/2005-July2012 for E-procurement (ICB Tenders). Special attention to the bidders is drawn to Section – E of the document.
- b) Technical specifications ,Quantity and General Notes for Tubing Head Housing & Assembly. as per Annexure 1A.
- c) The prescribed Bid Forms for submission of bids are available in the Technical Rfx -> External Area - > Tender Documents. Technical Checklist and Commercial Checklist vide <u>Annexure IV</u> must be filledup and submitted along with the technical bid.
- d) The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and

hence Nil Custom Duty during import will be applicable. Indigenous bidder shall be eligible for Deemed Export Benefit against this purchase. Details of Deemed Export are furnished vide Addendum to MM/GLOBAL/E-01/2005-July 2012 enclosed.

- 1.0 Please note that all tender forms and supporting documents are to be submitted through OIL's e-Procurement site only except following documents which are to be submitted manually in sealed envelope super scribed with <u>Tender no.</u> and <u>Due date</u> to <u>The Head Materials</u>, <u>Materials Department</u>, <u>Oil India Limited</u>, <u>Duliajan-786602</u>, Assam on or before 13:00 Hrs (IST) on the Bid Closing Date mentioned in the Tender.
 - a) Original Bid Security.
 - b) Detailed Catalogue.
 - c) Any other document required to be submitted in original as per tender requirement.

All documents submitted in physical form should be signed on all pages by the authorised signatory of the bidder and to be submitted in triplicate.

- 2.0 Bidders are requested to examine all instructions, forms, terms and specifications in the bid. Failure to furnish all information required as per the NIT or submission of offers not substantially responsive to the bid in every respect will be at the bidders risk and may result in rejection of its offer without seeking any clarifications.
- 3.0 All the Bids must be Digitally Signed using "Class 3" digital certificate (e-commerce application) with organisation name as per Indian IT Act obtained from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.
- 4.0 Bidders must ensure that their bid is uploaded in the system before the tender closing date and time. Also, they must ensure that above documents which are to be submitted in a sealed envelope are also submitted at the above mentioned address before 13:00 Hrs (IST) on the bid closing date failing which the offer shall be rejected.

The "TECHNO-COMMERCIAL UNPRICED BID" is to be submitted as per Scope of Work & Technical Specification of the tender and "PRICED BID" as per the Online Price Bid format in "Conditions Tab".
- 2) Bid should be valid for 180 days from bid closing date, failing which offer shall be rejected. Therefore, please ignore the minimum validity mentioned in the General Terms and Condition of Global Tender (MM/GLOBAL/E-01/2005-july 2012).

Bidder's Experience

In case the bidder is a manufacturer of the offered equipment/item, he should satisfy the following along with documentary evidence, which should be enclosed along with the technical bid.

(a) Minimum 5(five) years of experience of manufacturing of quoted item under indicated API certification (for this purpose, the period reckoned shall be period prior to the date of

opening of the technical bid). Experience details should be submitted in following format along with documentary evidence:

Documentary evidence in respect of the above should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as – (i) Satisfactory Inspection report or (ii) Satisfactory supply completion/installation report or (iii) Consignee receipted delivery challans or (iv) Central Excise Gate Pass/Tax Invoice issued under relevant rules of Central Excise/VAT or (v) any other documentary evidence that can substantiate the satisfactory execution of each of the Purchase Orders cited above.

Further in support of minimum 5 years of experience of manufacturing of quoted item under API certification, copy of API certificates with validity covering minimum 5 years continuously reckoned prior to the date of opening of the technical bid shall also be submitted.

(b) Should have manufactured and supplied to various Oil Companies viz., ONGC, Atwood Oceanic, ENSCO International, Nabors Industries, Noble Corp., Parker Drilling, Precision Drilling / Weatherford, Pride International, Transocean Inc., Pioneer Drilling, Diamond Offshore, Global SantaFe, SAIPEM, Schlumberger, TODCO/Hercules Offshore, KCA Deutag Drilling in the past.

Note: In case of any merger/acquisition with aforesaid companies the bidder should clearly bring out the same and submit documentary evidence thereof.

- (c) In case the manufacturer who has successfully supplied the item to OIL in the past, whose past performance has been satisfactory and are not in a position to submit supporting documents required for experience criteria as per (a) & (b) above, their offer will be considered provided they indicate the past supply reference indicating the order number & date in the bid itself.
- (d) In case the bidder is not a manufacturer, then the bidder is required to submit documentary evidence in respect of the (a) and (b) above from the concerned manufacturer (together with authorization certificate) along with the technical bid.
