Rotary Table, conforming to API specification 7K, cartridge type, lubricated with oil from reservoir having rectangular base and guard, positive table lock, pinion shaft assembly, unitized table bearing assembly, spiral bevel gear fitted by means of a service hub with heat treated 23 teeth API no. 3 single sprocket and complete with split square drive Master bushing & lifter for the same.

The Rotary table should have following specifications:

GENERAL NOTE FOR BIDDERS

1. Rotary Tables, Master bushing, lifters and sprockets are to be procured from same source.
2. Rotary table offered should have two independently operated ratcheting lock pawls, with one locking the table in one direction and the other in opposite direction. Both lock pawls should be capable of locking the gear table in at least 16 positions. Bidders should confirm this while quoting.
3. Pinion, pinion shaft bearings, gear, gear table bearings should be cascade lubricated from a central oil reservoir. Bidders should confirm this while quoting.

4. At the top of gear table enclosure, suitable arrangement should be there to prevent loss of oil and entrance of mud. Bidders should confirm this while quoting.

5. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.

6. Bidders should indicate the country of origin and port of despatch of the materials and their best delivery schedule.

8. Bidders are to indicate the name of manufacturer of each item and country of origin of the offered items.

7. Bidder should forward technical literature, catalogue, drawings with exploded views of each & every item, and a 02 year recommended spare parts list indicating part names & part numbers.

BID REJECTION CRITERIA(BRC)/BID EVALUATION CRITERIA(BEC)

BID REJECTION CRITERIA: TECHNICAL

The bids shall in general conform to the specifications and terms and conditions given in the tender. Bids shall be rejected in case the goods offered do not conform to the required minimum/maximum parameters stipulated in the technical specifications and to the respective international / national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the bids, without which the same will be considered as non-responsive and be rejected.

1.0 Manufacturing Experience: In case the bidder is a manufacturer of the offered equipment / item, he should satisfy the following along with documentary evidences, which should be enclosed along with the techno-commercial bid.

A. Minimum 5 years continuous experience of manufacturing of tendered item conforming to API spec. 7K. For this purpose, the period reckoned shall be period prior to the date of original bid closing date of the tender. Copies of API 7K certificates for the last 5 (Five) years (i.e. continuous without having any break in between) must be submitted along with techno - commercial bid. Bids without copies of valid API 7K certificates or with a break in between will be rejected.

A.1 They should have manufactured and supplied minimum 01(one) no of the tendered item to E&P companies/Drilling Contractors/Drilling service providers in the last 5(five) years as on original bid closing date of the tender (either by themselves or through their sole selling agent/distributor/dealer/ supply house). Documentary evidence in respect of manufacturing and supplying the quoted item should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as

I. Satisfactory Inspection Report (OR)

II. Satisfactory supply completion/installation report (OR)

III. Bill of Lading, Invoice etc. (OR)

A.2 Bidder quoted as manufacturer must guarantee uninterrupted supply of spares and availability of service for at least 10 years with effect from delivery of the Item / product for the item / product to be supplied under the Tender / Order, if order is awarded to them by OIL

B. If the bidder is a manufacturer and supplied the tendered items to OIL in the last 10(ten) years as on original bid closing date either by themselves or through their sole selling agent/distributor/dealer/supply house) and whose past performance has been satisfactory, the bidder need not satisfy Clause 1.0.A.1. In this situation the bidder shall have to indicate the Purchase Order (P.O.) No. of OIL in their technical bid.

2.0 In case the bidder is sole selling agent / distributor / dealer / supply house of any manufacturer, then the bidder is required to submit documentary evidence in respect of the above 1.0 (A & A.1) from the concerned manufacturer (having supplied such items either by manufacturer himself or his distributor) along with the techno-commercial bid.

3.0 In case the bidder is sole selling agent / distributor / dealer / supply house of any manufacturer, then the bidder must submit a letter of authorization along with the quotation to sell their products to OIL INDIA LIMITED from the original manufacture with warranty back-up and assurance to make spares available for at least the next 10 years. This certificate valid at the time of bidding and should remain valid during the entire execution period of the order.

COMMERCIAL:

1.0 COMMERCIAL:

1.0 Bids are invited under Single Stage Two Bid System. Bidders shall quote accordingly under Single Stage Two Bid System. Bidder to note that no price details should be furnished in the Technical (i.e. Unpriced) bid. The "Unpriced Bid" shall contain all techno-commercial details except the prices which shall be kept blank. The "Priced Bid" must contain the price schedule and the bidder's commercial terms and conditions. Bidder not complying with above submission procedure will be rejected.

2.0 **Bid security of US\$ 4700.00 or Rs. 3,17,000.00 shall be furnished as a part of the TECHNICAL BID.** Any bid not accompanied by a proper bid security in ORIGINAL will be rejected without any further consideration. For exemption for submission of Bid Security, please refer Clause No. 9.8 (Section A) of General Terms and Conditions for Global Tender. **The Bid Security shall be valid up to 09/03/2017. Bid shall be rejected straightway if Original Bid Security is not received within the Bid Closing Date & time mentioned in the Tender and/or Bid Security validity is shorter than the validity indicated in Tender and/or Bid Security amount is lesser than the amount indicated in the Tender.**

- 4.0 Successful bidder will be required to furnish a Performance Bank Guarantee @10% of the order value. The validity of Performance Security should be for a period of 12 months from the date of commissioning or 18 months from the date of dispatch/shipment, whichever concludes earlier. Bidder must confirm the same in their Technical Bid. Offers not complying with this clause will be rejected.
- 5.0 The prices offered will have to be firm through delivery and not subject to variation on any account. A bid submitted with an adjustable price will be treated as non-responsive and rejected.
- 6.0 **Validity of the bid shall be minimum 180 days from the Bid Closing date. Bids with lesser validity will be rejected.**

The Tools covered under this tender will be used by OIL in the PEL/ML areas issued/renewed after 01/04/99, applicable Customs Duty for import of goods shall be ZERO. Indigenous bidders shall be eligible for Deemed Export and should quote Deemed Export prices. Excise Duty under Deemed Export exempted. Necessary Project Authority Certificate (PAC) shall be issued by OIL towards this.

Bid Evaluation Criteria:

The bids conforming to the specifications, terms and conditions stipulated in the enquiry and considered to be responsive after subjecting to the Bid Rejection Criteria will be considered for further evaluation as per the Bid Evaluation Criteria given below:

COMMERCIAL:

- 1.0 The evaluation of bids will be done as per the Commercial Bid Format (SUMMARY) detailed vide Para 12.0 of BRC.
- 2.0 If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
- 3.0 For conversion of foreign currency into Indian currency, B.C. selling (Market) rate declared by State Bank of India, one day prior to the date of price bid opening shall be considered. However, if the time lag between the opening of the bids and final decision exceed 3(three) months, then B.C. Selling(Market) rate of exchange declared by SBI on the date prior to the date of final decision shall be adopted for conversion and evaluation.
- 4.0 Offers not complying with the payment terms indicated in the enquiry shall be loaded with one percent above the prevailing Bank rate (CC rate) of State Bank of

India for duration of commissioning time indicated in the tender plus transit time (3 months) for evaluation purpose.
