- 2.0 The Bidder shall furnish every detail of pump and motor as specified in the enquiry.
- 3.0 The Bidder shall categorically confirm that the pump and motor shall be supplied in unitized condition.
- 4.0 The bidder shall specifically confirm about the dynamic balancing of the impeller and provide necessary details thereof.
- 5.0 The bidder shall confirm that foundation drawing, operation and maintenance manual will be forwarded along with the materials in the event of placement of order.
- 6.0 The bidder shall confirm that test and guarantee certificate of motor and pump will be forwarded along with the materials in the event of placement of order.
- 7.0 The electrical motor & terminal box shall be conforming to the requirements of relevant Indian or International Standards.
- 8.0 The bidder shall confirm that Material Test Certificates of components like Casing, Impellers, and Pump Shaft etc. will be supplied along with the materials in the event of placement of order.
- 9.0 Bidder shall quote for all regular /recommended spares with part no along with the offer. However, prices of the recommended spares shall not be considered for evaluation of the bid. Procurement of spares shall remain at OIL's discretion.

The bids shall broadly conform to the specifications and terms and conditions given in this bid document. Bids shall be rejected in case the items offered do not conform to required parameters stipulated in the technical specifications and to the respective international/national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected.

**I. BID REJECTION CRITERIA (BRC)**

**(A) TECHNICAL**

12.0 Bidder shall accept and comply with the following clauses as given in the Bid Document, failing which bid shall be liable for rejection:

- i) Liquidated Damages
- ii) Warranty/Guarantee of material
- iii) Arbitration / Resolution of Dispute
- iv) Force Majeure
- v) Applicable Laws

13.0 A bid shall be rejected straightway if it does not conform to any one of the following clauses:

- a) Validity of bid shorter than the validity indicated in the Tender.
- b) Original Bid Security not received within the stipulated date & time mentioned in the Tender.
- c) Bid Security with (i) validity shorter than the validity indicated in Tender and/or (ii) Bid Security amount lesser than the amount indicated in the Tender.

## **II) BID EVALUATION CRITERIA**

The bids conforming to the specifications, terms and conditions stipulated in the enquiry and considered to be responsive after subjecting to the Bid Rejection Criteria will be considered for further evaluation as per General Terms and Conditions for Global Tender and the Bid Evaluation Criteria given below:

- 1.0 The evaluation of bids shall be done as per the Price Bid Format (SUMMARY) provided in the Tender and detailed below
- 2.0 If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
- 3.0 For conversion of foreign currency into Indian currency, B.C. selling (Market) rate declared by State Bank of India, one day prior to the date of price bid opening shall be considered. However, if the time lag between the opening of the bids and final decision exceed 3(three) months, then B.C. Selling(Market) rate of exchange declared by SBI on the date prior to the date of final decision shall be adopted for conversion and evaluation.
- 4.0 To ascertain the inter-se-ranking, the comparison of the responsive bids will be made as under, subject to corrections / adjustments given herein.

Note: 1) Domestic Bidders must quote inland freight charges upto Duliajan.
