BB :: SPECIAL NOTES TO BIDDERS

I. NOTE FOR ITEM NO 10

1. All the items shall be made in accordance to API 6A and certificate from API in this effect shall be submitted along with the bid.
2. The ID should be 2 inch (50.8 mm)
3. The service of all the items shall be for smooth service.
4. The supplier shall provide two copies of technical manuals viz, user and maintenance manuals, schematic and circuit diagrams etc. in English (for each item) at the time of delivery of the items.
5. Supplier shall have to test all these equipments thoroughly before their despatch and necessary Test Certificates will be provided by the supplier at the time delivery of the items.
6. The items as well as their spares shall be brand new, unused and of prime quality and also from original manufacturer. The supplier shall warrant that the products supplied will be free from all defects and fault in material, workmanship and manufacture and shall be in full conformity with ordered specifications.
7. The supplier shall have to provide all the accessories/spares for initial commissioning.

II. OTHER NOTES

1. The bidder shall furnish a list of spares that will be required for regular operation and maintenance etc. throughout the life of the equipment complete with the price if each item along with the bid. Annual consumption of each spare should be furnished. The price quoted for recommended spares will not be taken in to account for bid evaluation.
2. Bidder other than OEM must submit valid authorisation certificate along with warranty back up for OEM.
3. The bidder shall require producing the test certificate (in original from OEM) of the equipment at the time of delivery.
4. The bidder shall furnish detailed technical drawings and literature along with the bid for technical evaluation.
5. The bidders should also submit a list of companies in India to whom they sold this particular equipment which are presently in operation. The supplier may also be required to provide after sales service in India
6. The items shall be brand new, unused & of prime quality. Also the party has to confirm to provide warranty that the product supplied will be free from all defects & fault in material, workmanship & manufacturing and shall be in full conformity with ordered specifications. 29.1	In case of placement of order, OIL reserves the right to convert the order from FOB Port of export to C&F Kolkata term considering the ocean freight quoted by the party in their offer. In case the order is converted to C&F Kolkata Port, the performance security amount shall also be enhanced considering the quoted ocean freight charges.
29.2	Bidder should confirm in their quotation that in case of C&F order, their nominated freight forwarder should provide Delivery Order under Single Window facility having office of local agent in India at Kolkata and offer 14 days free detention time of containers at discharging port.
29.3	Bidder should note that in case of C&F order for Tubulars, the same to be supplied in break bulk condition under deck and not through Container load.
30.0	FURNISHING FRAUDULENT INFORMATION/ DOCUMENT: If it is found that a Bidder has furnished fraudulent document/information, the Bid Security/Performance Security shall be forfeited and the party will be debarred for a period of 3(three) years from date of detection of such fraudulent act, besides the legal action. In case of major and serious fraud, period of debarment may be enhanced. In this regard, bidders are requested to submit an Undertaking as per Appendix-A3 along with their offer failing which their offer shall be liable for rejection.

Clauses related to GST

1. For the purposes of levy and imposition of GST, the expressions shall have the following meanings:
 - (a) GST - means any tax imposed on the supply of goods and/or services under GST Law.
 - (b) Cess – means any applicable cess, existing or future on the supply of Goods and Services as per Goods and Services Tax (Compensation to States) Act, 2017.
 - (c) GST Law - means IGST Act 2017, CGST Act 2017, UTGST Act, 2017 and SGST Act, 2017 and all related ancillary Rules and Notifications issued in this regard from time to time.
2. The rates quoted by the bidders shall be inclusive of all taxes, duties and levies. However, bidders are required to provide separately the rate and amount of all types of taxes, duties and levies. In case, the quoted information related to various taxes, duties & levies subsequently proves wrong, incorrect or misleading, OIL will have no liability to reimburse the difference in the duty/ tax, if the finally assessed amount is on the higher side and OIL will have to right to recover the difference in case the rate of duty/ taxes finally assessed is on the lower side. Further, bidders have to clearly show the amount of GST separately in the Tax Invoices. Further, it is the responsibility of the bidders to make all possible efforts to make their accounting / IT system GST compliant in order to ensure availability of Input Tax Credit (ITC) to Oil India Ltd.
3. Offers without giving any of the details of the taxes (Including rates and amounts) as specified above will be considered as inclusive of all taxes including GST. When a bidder mentions taxes as extra without specifying the rates & amount, the offer will be loaded with maximum value towards taxes received against the tender for comparison purposes. If the bidder emerges as lowest bidder after such loading, in the event of order on that bidder, taxes mentioned by OIL on the Purchase Order/ Contracts will be binding on the bidder.
4.
