**BB :: SPECIAL NOTES TO BIDDERS**

1. The items shall be brand new, unused & of prime quality. Also the party has to confirm to provide warranty that the product supplied will be free from all defects & fault in material, workmanship & manufacturing and shall be in full conformity with ordered specifications. This clause shall be valid for 12 months from date of receipt/commissioning of the item at Oil India Limited, Duliajan. The defective materials within the period of 12 months from the date of receipt/commissioning whichever is later, if any, rejected by us shall be replaced by the supplier at their own expense. The bidder must confirm the same while quoting.

2. The Fume hood and all its accessories shall be compatible for operation at 220/230 V, 50 Hz AC power supply.
3. The bidder should submit the original model-specific product brochure along with the bid document, **Annexure - D** (NO DEVIATION CONFIRMATION) and **Annexure - E** (TECHNICAL COMPLIANCE STATEMENT). The offer should clearly indicate the compliance of offered specification vis-à-vis tender specifications with the deviations clearly marked.
4. The Fume hood is to be supplied with the following documentation:
  - a) Original model-specific operation and maintenance manuals with electrical wiring diagrams.
  - b) Brief Safe Operating Procedure (SOP) in laminated form to be provided with the apparatus.
5. The Fume hood is to be installed and commissioned at R&D Department, Oil India Ltd., Duliajan along with onsite User's training on operation cum demonstration of the instrument.
6. The Fume hood should carry on-site comprehensive warranty of one year minimum from the date of installation, and should be serviceable during and after the warranty period for a period of five years by an authorized and trained service engineer stationed in India.
7. The bidder should provide declaration that the service support for the offered item will be available for a period of at least 5 years post warranty
