BB:: SPECIAL NOTES TO BIDDERS:

- 1.0 The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt items at site, whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.

The relevant warranty certificate from the OEM of materials should be submitted at the time of delivery of the materials.

- 2.0 The supplier should specify make/model/part no. of the items as the case may be in the quotation. Since the hose will be used as delivery hose, the bidder is required to mention in their offer the maximum working pressures as well as bursting pressure of the offered hose.
- 3.0 The supporting Literature, drawing, operating manual, catalogue must be submitted along with the offer for technical evaluation. The specifications mentioned in the quote should conform to the details indicated in literature/catalogue/ drawings.
- 4.0 The supplier should demonstrate about the use of hoses and instruct about the preservation of the pipes.
- 5.0 All the relevant paper, specification, copy of ISI and other relevant (UL, EN) standard certificate etc. have to be supplied along with quotations.

6.0 Packing:

- a) The packing shall be roadworthy for transportation up to site, sufficiently robust to withstand rough handling.
- b) Boxes/ packing cases shall be rodent proof.

7.0 Pre-Dispatch Inspection & Testing:

OIL as purchaser shall have the right to carry out inspection and shop visit to review the manufacturing progress but such inspection shall not relieve the bidder of his responsibility to ensure that the equipment supplied is free from all manufacturing and other defects and conform to correct specifications. The bidder/manufacture shall inform OIL in advance (four weeks if in India & sixteen weeks if abroad) for inspection at OEM/suppliers premises. However, manufacturer should not hold any manufacturing activity for witness of purchaser's stage inspection. OIL shall have the right to waive such inspection.

8.0 PREDELIVERY INSPECTION:

- a) Pre-delivery inspection shall be performed by OIL to ensure all components etc. are included as specified herein, free from any defects and can fulfill all the requirements as specified prior to delivery and acceptance.

- b) The testing of Brand NEW FLEXIBLE FIRE FIGHTING DELIVERY HOSE shall necessarily be carried out at factory/ manufacturer premises/bidder's premises in presence of representatives of OIL.
- c) The manufacturer or its representative shall give a notice in advance of minimum four weeks for carrying out pre-delivery inspection and shall arrange for consumables for testing at their cost.
- d) OIL shall witness such inspection & testing at mutually agreed date. For inspection, all to & fro fares, boarding/lodging and other daily expenses of OIL engineer(s) shall be borne by OIL.
- e) Any defect/ abnormality noticed during testing shall be rectified. The testing will be declared successful only when no abnormality/ failure is noticed during the testing.
- f) Any defects which become evident during the test shall be corrected by the bidder at his own expense prior to dispatch to OIL.
- g) The BRAND NEW FLEXIBLE FIRE FIGHTING DELIVERY HOSE will be cleared for dispatch to site only when the testing is declared successful by OIL.

9.0 **DISPATCHES TO SITE:**

- 9.1 The items shall be dispatched only after OIL's satisfactory inspection and advice.
- 9.2 No environmental damage shall be done while carrying out the job.

10.0 **SERVICE AND WARRANTY:**


- 10.1 The supplier shall ensure adequate and prompt after sales service free of cost during warranty period, and against payment after the warranty period is over.
- 10.2 The warranty period for the BRAND NEW FLEXIBLE FIRE FIGHTING DELIVERY HOSE with all accessories should be a minimum of 18 months from the date of dispatch or 12 months from the date of receipt, whichever is earlier.

The bids shall broadly conform to the specifications and terms and conditions given in this bid document. Bids shall be rejected in case the items offered do not conform to required parameters stipulated in the technical specifications and to the respective international/national standards wherever stipulated.
