BB:: SPECIAL NOTES TO BIDDERS:

1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with order specifications. This clause shall be valid for 18 months from date of shipment/dispatch or 12 months from the date of successful installation of the items, whichever is earlier. The defective materials, if any, rejected by OIL shall be replaced by the supplier at their own arrangements. Bidders must confirm the same in their quotations.

2. The bidder must specify the offered items in details, forwarding relevant product catalogue, literature, detailed drawings with exploded views of the offered product with complete spare parts list & clearly indicating the various parts with part numbers.

3. The units should be suitable for operation using plain water / water with soluble oil mixture.

4. The items shall be die stamped with the manufacturer's name, month and year of manufacture. Bidders are to confirm the same while quoting.
