- 3.0 Bidders without having E-tender Login ID and Password should complete their online registration at least 7(seven) days prior to the scheduled bid closing date and time of the tender. For online registration, Bidder may visit the OIL's E-tender site https://etender.srm.oilindia.in/irj/portal.
- 4.0 Necessary Login ID & Password will be issued by OIL only after submitting the complete online registration by the Bidder. In the event of late registration/incomplete registration by Bidder, OIL INDIA LIMITED shall not be responsible for late allotment of User ID & Password and request for bid closing date extension on that plea shall not be entertained by Company.
- 5.0 Bidders to note that Govt. of India under Micro, Small and Medium Enterprises Development (MSMED) Act 2006, has proclaimed the Public Procurement Policy, 2012 with effect from 1st April, 2012 in respect of procurement of goods and services, produced and provided by micro and small enterprises, by its Ministries, Departments and Public Sector Undertakings for promotion and development of Micro and Small Enterprises. A new Clause on applicability of Public Procurement Policy for procurement of goods from Micro and Small Enterprises (MSE) in the tender is furnished vide Amendment to General Terms and Conditions for Global Tender (MM/GLOBAL/E-01/2005). - iii) 100% Valve casting shall undergo radiographic examination
- iv) Stem packing shall be renewable with Valve Open on stream.
- v) Painting of the valves shall be as per Manufacturer's Standard.
- vi) Compressed asbestos filler (CAF) shall not be used for body sealing/gasket material.
- vii) Valves shall be supplied with locking devices.

J) Inspection & Testing:

- ii) Every valve shall be subjected to all the mandatory tests and checks called in the respective codes / specification sheet or any third party as approved by the purchaser.
- iii) Every valve, its components and auxiliaries must be subjected to all the mandatory tests and checks called for in the respective codes, data sheets etc. by the manufacturer.
- iv) Though the extent of inspection (by TPI) shall be as under, exact extent with 'Hold Points' shall be as per inspection plan.
 - a) Visual and dimensional inspection.
 - b) Review of material test certificates.
 - c) Review of radiographs/radiographic reports or any other NDT tests wherever applicable.
 - d) Any mandatory or supplementary test.
- v) Radiography procedure, areas of casting to be radiographed shall be as per ASME B 16.34 and acceptance criteria shall be as per ASME B 16.34 Annexure-B. However, for areas of casting to be radiographed for types of valves not covered in ASME B 16.34, vendor shall radiograph castings in line with ASME B 16.34.
- vi) Inspection plan as per <u>Annexure HH</u> or Quality Assurance Plan as approved by Customer shall be followed.
- vii) The supplier shall also intimate OIL at least 15 (fifteen) days in advance prior to starting the 'third party inspection' at manufacturing facility/ plant to enable OIL for associating their personnel to witness the process of manufacturing and coating. All to-&-fro travel, boarding & lodging expenses for OIL's Inspection personnel shall be to OIL's account. However, all facilities required for inspection/ testing shall be provided by the successful bidder to OIL's Inspection personnel.

M) Marking:

- i) API Monogram, Valve markings, symbols, abbreviations etc. shall be in accordance with MSS-SP-25/ API 6D or the standard referred in specification sheet as applicable. Vendor's name, valve rating, material designation, nominal size, direction of flow (if any) etc. shall be integral on the body.
- ii) Each valve shall have a corrosion resistant tag giving size, valve tag / code no., securely attached to the valve body.

N) Warranty:

Warranty shall be 18 months from the date of dispatch/ shipment or 12 months from the date receipt at site, whichever is earlier.

O) Despatch:

- Valve shall be dry, clean and free from moisture, dirt and loose foreign materials of any kind.
- ii) Valves shall be protected from rust, corrosion and any mechanical damage during transportation, shipment and storage.
- Rust preventive on machined surfaces to be welded shall be easily removable with a petroleum solvent or shall not be harmful to welding.
- iv) Each end of valve shall be protected with the following materials:

Flange Face: Wood or Plastic Cover

Bevelled End: Wood or Plastic Cover

SW & SCRD. End: Plastic Cap

v) End protectors of wood / plastic to be used on flange faces shall be attached by at least three bolts and shall not be smaller than the outside diameter of the flange. However, plastic caps for SW & SCRD end valves shall be press fit type.

BID REJECTION CRITERIA/BID EVALUATION CRITERIA

I. BID REJECTION CRITERIA (BRC):

The bids must conform to the specifications, terms and conditions given in the tender document. Bids shall be rejected in case the items offered do not conform to the required minimum/ maximum parameters stipulated in the technical specifications and to the respective international /national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the offer/ offers will be considered as non-responsive and is/are liable to be rejected, if the following conditions are not fulfilled:

(A) TECHNICAL

1.0 The bidder should be an Original Equipment Manufacturer (OEM) of the tender item.

OF

The bidder should be the authorized Dealer/Distributor/Sole Selling Agent/ Supply House of an Original Equipment Manufacturer (OEM) of the tender item.

2.0 IN CASE THE BIDDER IS AN ORIGINAL MANUFACTURER (OEM):

If the bidder is a manufacturer, then they must satisfy the following criteria and furnish the relevant documentary evidences as under along with the technical bid:

- 2.1 The bidder should be Manufacturer of "Through Conduit Gate Valve" for the last five (5) years preceding the original bid closing date of the tender.
- 2.2 The Original Equipment Manufacturer (OEM) shall be holding relevant API certificate(s) with continuous validity for 5 years preceding original bid closing date of the tender. Copy of the relevant API certificate(s) shall be submitted along with the technical bid. The API Certificate should remain valid throughout the duration of Purchase Order for execution, including extension, if any.
- 2.3 The bidder shall have experience of successful execution of past supply for minimum 2 nos. of the tender item of same or higher size & rating (class, WP, PSL, PR etc.) as specified in the tender in a single purchase order/contract awarded in last 5 years preceding the original bid closing date of the tender, to any Oil & Gas Industry, either by themselves or through their agent/dealer/distributor/stockiest/supply house.
- 2.4 The following supporting documents with respect to bidder's past supply experience as per para 2.3 must be uploaded/submitted along with the technical bid, failing which the bid shall be considered as incomplete/non-responsive and rejected.
