- The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt of the item at site which ever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.
- The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted

would be prorata calculated and the same will be binding on the bidder.

3. Bidders other than OEM (Original Equipment Manufacturer) must submit proper valid authorisation certificate alongwith the warranty back-up from OEM failing which offer shall be liable for rejection

4. The bidder shall confirm that the gas sampler design shall be approved by PED(Europe)/ DOT(USA)/ TC (Canada) and copy of relevant approval document should be submitted along with technical bid.

5. The bidder shall confirm that the gas sampler shall be hydraulically tested at test pressure (min) 1.5 times of the working pressure as per relevant approval / certification from PED(Europe)/ DOT(USA)/ TC(Canada).

6. The bidder shall submit along with the technical bid copy of technical literature / catalogue comprising of the following :-

- a. Detailed drawing and technical specification
- b. Operating & maintenance manual

7. Validity of the offers should be 120 days from the date of bid opening. Bids with lesser validity shall be rejected.

8. Quotation must be submitted in triplicate.

9. The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Customs Duty during import will be applicable.
