This clause shall be valid for 18 months from date of shipment/despatch or 12 months from the date of receipt/commissioning of the items at site which ever is earlier. The defective materials, if any, rejected by OIL shall be replaced by the supplier at their own expenses on F.O.R destination basis. Bidder must confirm the same in their quotation.

2. Items shall be manufactured, tested & certified as per API Spec. 8C and mill inspection certificate thereof should be forwarded along with supply. Bidders to confirm the same while quoting. A copy of valid API Spec 8C certificate must be forwarded along with the offer.

3. Markings (including API monogram) shall be done as per API Spec 8C. Additionally, purchase order number should be die stamped along with the name of manufacturer. Bidder should confirm while quoting.

4. The quotation must accompany relevant catalogue, literature, drawing illustrating all components with part name & part number etc.

5. Bidder must forward a list of recommended spares indicating the item, part no., quantity & price for two years successful operation. The price of spares will not be considered for evaluation purpose. However, procurement of this spares shall be at OIL's discretion.
