5.0. The rates shall be quoted per unit as specified in the schedule of work (Part-II) and shall be in words as well as in figures. No over-writing shall be allowed, but all corrections may be inserted in the blank space above the corrected words/figure and must be initialed. In case of discrepancy, the rates, quoted in words shall be considered to be correct.

6.0. Before tendering the Tender is advised to inspect the work site with permission from the Dy.Chief Engineer or his representative to assess the nature and extent of the work and the conditions under which it will be carried out, may also seek such clarification from this office as deemed necessary.

The Schedule tender will be required to enter into a formal contract which will be based on his tender on the OIL Standard Form of contract.

The successful tenderer (s) shall furnish a security deposit in form of Bank Draft as specified above before signing the formal contract. The security deposit will be refunded to the contractor after satisfactory completion of the work, but part or whole of which shall be used by the Company in realization of liquidated damage if any, or for adjustment of compensation/loss due to the Company for any reason. This security money shall not earn any interest.

The amount of retention money shall be released after 6 (six) months from the date of issue of completion certificate from concerned department and this money shall not earn any interest.
