BID REJECTION CRITERIA (BRC)

- A) Financial capability: Bidders must have
 - 1. Average Annual financial turnover as per Audited Annual Reports for the <u>last three</u> accounting years should be at least ₹ 46,252.10/- (Forty Six thousand Two hundred fifty two only).

For Proof of Annual Turnover any of the following documents /photocopy must be furnished

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.
- 2. Experience: Bidders must have;
 - 2.1 <u>Experience of having successfully completed</u> Environmental Quality/ Stack Gas Monitoring for any organizations/establishments during <u>last seven years ending on 13-12-2014</u> and value of such works should be either of the followings:
 - (i) Three similar completed works each costing not less than ₹61,700.00

Or

(ii) Two similar completed works each costing not less than ₹77,100.00

Or

(iii) One similar completed works each costing not less than ₹1,23,400.00

2.2 Documentary evidence in support of fulfilling the requirement as spelt in 2.1 above must be in the form of copies of Completion Certificate. For the purpose of clarity and to know regarding the detailed scope of work executed by the bidder, the corresponding Work Order/ Contract shall also be submitted by the bidder.

B) **EVALUATION OF BIDS:**

BID EVALUATION CRITERIA (BEC)

- 1. Bids conforming to the terms and conditions stipulated in the bid document and considered responsive and subject to qualifying the Bid Rejection Criteria will be considered for further evaluation.
