BID EVALUATION CRITERIA / BID REJECTION CRITERIA :

(A)TECHNICAL

1. Bid should be complete in all aspect covering the entire scope of supply and should conform to the technical specifications indicated in the bid documents duly supported with technical catalogues / literatures wherever required. Incomplete and non-conforming bids will be rejected outright.

2. Manufacturer's Experience:

In case the bidder is a manufacturer of the offered items, bidder should satisfy the following with

documentary evidence, which should be enclosed along with the bid.

- a. Minimum 3 (three) years experience in manufacturing / supply of the item: (For this purpose the period reckoned shall be the period prior to the date of opening of the bid).
- b. Should have manufactured and supplied 25% of offered quantity of the item to various companies during the last 03 (three) years.

Documentary evidence in respect of the above should be submitted in the form of copies of relevant purchase orders along with copies of any of the documents in respect of satisfactory execution of each of those purchase orders, such as (i) Satisfactory inspection report (OR) (ii) Satisfactory supply completion / installation report (OR) (iii) Consignee Receipted Delivery Challans (OR) (iv) Central Excise Gate Pass / Tax Invoices issued under relevant rules of Central Excise / VAT (OR) (v) any other documentary evidence that can substantiate the satisfactory execution of each of the purchase orders cited above.

2.1 In case the bidder is not a manufacturer, then the bidder is required to submit documentary evidence in respect of 2 (a) and (b) of the concerned manufacturer (having supplied such items either by manufacturer himself or his distributor) along with the bid.

(B) COMMERCIAL:

1.0 The prices offered will have to be firm through delivery and not subject to variation on any account. A bid submitted with an adjustable price will be treated as non-responsive and rejected.

2.0 Bids received after the bid closing date and time will be rejected. Similarly, modifications to bids received after the bid closing date & time will not be considered.

3.0 Original signed offer should be submitted in sealed envelope. No offers should be sent by Telex, Cable, E-mail or Fax. Such offers will not be accepted.

5.0 Validity of the bid shall be minimum 75 days. Bids with lesser validity will be rejected.

6.0 Bids containing incorrect statement will be rejected.
