- 2.0 Technical Literature/Drawing of the items shall be submitted along with the offer for technical evaluation.
- 3.0 Any Hose and the End Connection of the hose shall be of same make. Bidder has to confirm the same in the offer.
- 4.0 The PR contains 36 types of hoses of different specifications. Hydraulic test certificate of atleast one no. hose of each type must be furnished along with the supply. The

bidder shall confirm the same in its offer.

- 5.0 The hoses should be of make Parker, Gates, Eaton, Powergrip or Vickers only. The bidder should mention in the offer the exact make of hoses to be supplied.
