This clause shall be valid for 18 months from date of shipment or 12 months from date of commissioning of the items, whichever is earlier. The defective materials, if any, rejected by OIL shall be replaced by the supplier. Bidders must confirm the same in their quotations.
- 2. The manufactured product should be strictly as per OIL's tender specification. Bidder to confirm the same while quoting.
- 3. In case the bidder is not an OEM and is an authorized supplier/dealer of the product, then bidder has to submit authorization certificate from the manufacturer along with the bid.

- 10. Manufacturers name along with tool size shall be clearly embossed on each item.
- 11. The bidder shall clearly mention the tools against each UNIT in a tabular form along with the bid. Part offer from the bidder will be liable for outright rejection.
