receipt of the items. Bidders must confirm the same while quoting.

2. The minimum FOB/FCA charges in case of partial order for reduced quantity/items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorata calculated and the same will be binding on the bidder.

3. The Make and Model of the offered instrument should be clearly mentioned in the offer document. The original product brochure / catalogue (from the OEM) of the offered model must accompany the quotation submitted against this enquiry..

4. Bidders other than OEM (Original Equipment Manufacturer) must submit proper valid authorisation certificate alongwith the warranty back-up for 1(one) year from the date of commissioning of the equipment from OEM failing which offer shall be liable for rejection.

11. The bid documents should include a confirmation from the original equipment manufacturer (OEM) that the spares for the quoted model shall be available for a minimum period of five years from the date of installation of the instrument.

12. Validity of the offers should be 90 days. (Please refer clause 1.2 of Section 'D' of MM/GLOBAL/01/2005). Bids with lesser validity shall be rejected.

13. Quotation must be submitted in triplicate.
