1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.
 2. The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorata calculated and the same will be binding on the bidder.
 3. All rotary substitutes shall have API bore back box and / or API stress relief groove on pin ends (wherever applicable) as per API Spec 7.
 4. Thread roots of all the rotary substitutes shall be cold rolled & phosphatised.
 5. All the connections should be coated with thread lubricants and protected with pressed steel thread protectors.

6. Items shall be manufactured, tested & certified as per API Spec.7-1 and mill inspection certificate thereof should be forwarded along with supply. Bidders to confirm the same while quoting. A copy of valid API Spec 7-1 certificate must be forwarded along with the offer.

7. Markings (including API monogram) shall be done as per API Spec 7-1. Additionally, purchase order number should be die stamped along with the name of manufacturer. Bidder should confirm while quoting.

8. The quotation must accompany relevant catalogue, literature, drawing, etc. Drawing indicating length, OD, bore, size & style of connection should be forwarded for each item.

9. Bidder should have an experience of minimum 5 (five) years in manufacturing the quoted items under API Spec.7-1 certification. For this purpose the period reckoned shall be the period prior to the date of opening of the techno-commercial bid. Copies of API Spec.7-1 certificates for the last 5 (Five) years (i.e. continuous without having any break in between) must be submitted along with techno- commercial bid. Bids without copies of valid API Spec.7-1 certificates or with a break in between will be rejected.

10. In case the bidder is sole selling agent / distributor / dealer / supply house of any API approved manufacturer, then bidder must furnish the following documents:

(i) Back-up authority cum warranty letter in original on manufacturer's letter head, valid at the time of bidding which should remain valid during the entire execution period of the order, from the concerned manufacturer guaranteeing supply of the items to the bidder in the event of an order on the bidder and also authorized them to market their products.

(ii) Copies of valid API Spec.7-1 certificate of manufacturer as stated in point 6 above.

Validity of the offers should be 120 days from the date of bid opening. Bids with lesser validity shall be rejected.

11. Quotation must be submitted in **triplicate**.

12. The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Customs Duty during import will be applicable. Deemed Export Benefit for domestic bidders is not applicable against this tender. Domestic Bidders to quote their prices without considering the Deemed Export Benefit. Domestic bidders to also quote the applicable rate of Excise Duty in their price bid.
