1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall receipt items at site whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.
 2. The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorata calculated and the same will be binding on the bidder.
 3. Bidder should forward relevant catalogue, literature, drawing, dimensional details etc. along with quotation.
 4. All thread connections must conform to API Spec. 7-1. Bidders to confirm the same while quoting.
 5. Valid Copies of API 7-1 certificates for the last 3 (three) years (i.e. continuous without having any break in between) must be submitted along with techno - commercial bid. Bids without copies of valid API 7-1 certificates or with a break in between will be rejected.
 6. Bidders shall furnish a recommended 3 years operational spares list (containing Part Description, Part number & unit price) along with the quotation. Cost of the these spares will not

be considered for bid evaluation. However, procurement of these spares shall be at OIL's discretion.

7. Bidder should indicate the name of manufacturer, country of origin and best delivery schedule.

8. Items in the event of order should be embossed (die stamping) with purchase order number & date of manufacture. Bidders shall confirm compliance to the same while quoting.

9. Any deviation(s) from the tender specification should be clearly highlighted specifying justification in support of deviation.

10. There are two line items in the NIT. Cost of each line item to be quoted separately. Bidders are to quote for all the items of individual line item, failing which the bid will be rejected.

11. In case the bidder is sole selling agent / distributor / dealer / supply house of any API approved Original Equipment manufacturer (OEM), then bidder must furnish the following documents:

11.1 Back-up authority cum warranty letter in original on manufacturer's letter head, valid at the time of bidding which should remain valid during the entire execution period of the order, from the concerned manufacturer guaranteeing supply of the items to the bidder in the event of an order on the bidder and also authorized them to market their products.

11.2 The bidders quoting on behalf of the manufacturers must also submit undertaking in original from the manufacturer for back up guarantee and after sale services with effect from delivery of the Item / product for the item / product to be supplied under the Tender / Order, if order is awarded to them by OIL.

11.3 Copies of valid API Spec 7-1 certificates of manufacturer as stated in point 5 above.

12. Validity of the offers should be 120 days from the date of bid opening. Bids with lesser validity shall be rejected.

12. Quotation must be submitted in triplicate.

13. The items covered by this tender shall be used by Oil India Limited in the PEL/ML areas which are issued/renewed after 01/04/99 and hence Nil Customs Duty during import will be applicable.
