9.1 The bidder should have an experience of minimum 3 (three) years in manufacturing the tendered item under API Spec. 7K certification. For this purpose the period reckoned shall be the period prior to the date of opening of the techno-commercial bid. Copies of valid API 7K certificates for the last 3 (three) years (i.e. continuous without having any break in between) must be submitted along with techno - commercial bid. Bids without copies of valid API 7K certificates or with a break in between will be rejected.

10. In case the bidder is sole selling agent / distributor / dealer / supply house of any API approved Original Equipment manufacturer (OEM), then bidder must furnish the following documents:

10.1 Back-up authority cum warranty letter in original on manufacturer's letter head, valid at the time of bidding which should remain valid during the entire execution period of the order, from the concerned manufacturer guaranteeing supply of the items to the bidder in the event of an order on the bidder and also authorized them to market their products.

10.2 The bidders quoting on behalf of the manufacturers must also submit undertaking in original from the manufacturer for back up guarantee and after sale services with effect from delivery of the Item / product for the item / product to be supplied under the Tender / Order, if order is awarded to them by OIL.

10.3 Copies of valid API Spec 7K certificates of manufacturer as stated in point 9.1 above.
